**CHAPTER 83**  
**SENATE BILL 1134**

AN ACT

APPROPRIATING MONIES FOR THE RELIEF OF NAMED CLAIMANTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Appropriations for relief of named claimants:  
 3 basis of claims; coordination

4 A. The payment of the sums appropriated by this section is in  
 5 full satisfaction of the claims described in this section. The  
 6 department of administration shall coordinate payments.
