**CHAPTER 114**  
**SENATE BILL 1007**

AN ACT

APPROPRIATING MONIES; MAKING ASSESSMENTS; RELATING TO THE NUCLEAR EMERGENCY MANAGEMENT FUND.

1 Be it enacted by the Legislature of the State of Arizona:

2       Section 1. Appropriations; nuclear emergency management fund

3       Pursuant to sections 26-306.01 and 26-306.02, Arizona Revised  
4 Statutes, the sum of \$2,434,868 in fiscal year 2023-2024 and the sum of  
5 \$2,484,600 in fiscal year 2024-2025 are appropriated from the nuclear  
6 emergency management fund established by section 26-306.02, Arizona  
7 Revised Statutes, as follows:

8       1. For use by the division of emergency management of the  
9 department of emergency and military affairs as provided in section  
10 26-306.02, Arizona Revised Statutes, the sum of \$1,160,764 and 8.5  
11 full-time equivalent positions in fiscal year 2023-2024 and the sum of  
12 \$1,185,598 and 8.5 full-time equivalent positions in fiscal year  
13 2024-2025.

14       2. For use by the Arizona department of agriculture for programs  
15 relating to off-site nuclear emergency response plans, the sum of \$321,319  
16 and 2.88 full-time equivalent positions in fiscal year 2023-2024 and the  
17 sum of \$308,569 and 2.88 full-time equivalent positions in fiscal year  
18 2024-2025.

19       3. For disbursement by the division of emergency management of the  
20 department of emergency and military affairs to departments and agencies  
21 of Maricopa county assigned responsibilities under the off-site nuclear  
22 emergency response plan, the sum of \$862,785 in fiscal year 2023-2024 and  
23 the sum of \$900,433 in fiscal year 2024-2025.

24       4. For disbursement by the division of emergency management of the  
25 department of emergency and military affairs to departments and agencies  
26 of the city of Buckeye that are assigned responsibilities under the  
27 off-site nuclear emergency response plan, the sum of \$90,000 in fiscal  
28 year 2023-2024 and the sum of \$90,000 in fiscal year 2024-2025.

29       Sec. 2. Assessments

30       Pursuant to section 26-306.01, Arizona Revised Statutes, the sum of  
31 \$2,434,868 in fiscal year 2023-2024 and the sum of \$2,484,600 in fiscal  
32 year 2024-2025, plus any applicable interest, are assessed against each  
33 consortium of public service corporations and municipal corporations  
34 engaged in constructing or operating a commercial nuclear generating  
35 station in this state.

36       Sec. 3. Emergency

37       This act is an emergency measure that is necessary to preserve the  
38 public peace, health or safety and is operative immediately as provided by  
39 law.
