A CONCURRENT RESOLUTION

ON THE DEATH OF THE HONORABLE RUSSELL K. PEARCE.

1 The Honorable Russell K. Pearce passed away on January 5, 2023 in
2 Mesa at the age of 75 after a brief illness.

3 Russell Pearce was born on June 23, 1947 and was a fifth generation
4 Arizonan, growing up in a blended family that totaled 13 children. He
5 honorably served in the Army National Guard from 1965 to 1972. During that
6 time, he served a two-year mission from 1967 to 1969 for the Church of
7 Jesus Christ of Latter-Day Saints in the areas of New York City, New
8 Jersey, Connecticut and Massachusetts.

9 A life-long learner, Russell Pearce earned a bachelor's degree in
10 management from the University of Phoenix in 1981. He continued his
11 education by earning several certificates, including certificates from
12 Harvard University, John R. Kennedy School of Government, Arizona State
13 University in Advanced Executive Development, the University of Colorado,
14 Motor Vehicle Legal and Law College, Arizona State University in Budget
15 and Appropriations and the Supreme Court of Arizona, Arizona Judicial
16 College.

17 Russell Pearce cared deeply about Arizona, and he worked in a
18 variety of public servant jobs his entire life. Before being elected to
19 office, he worked as a deputy sheriff with the Maricopa County Sheriff's
20 Office from 1970 to 1991, and from 1993 to 1994 he served as the chief
21 deputy. After being shot and critically wounded in the line of duty, he
22 was nominated for the Medal of Valor award, which is the highest award in
23 law enforcement.

24 Continuing his civil service, Russell Pearce served as a judge in
25 the North Mesa Justice Court, a pro-tem judge in the Maricopa County
26 Justice Courts, the director of the Governor's Office of Highway Safety,
27 the director of the Arizona Motor Vehicle Division and the chief deputy
28 director of the Maricopa County Treasurer's Office.

29 Russell Pearce was elected to the Arizona House of Representatives
30 in 2001 until his term limit in 2009 and was subsequently elected to the
31 state Senate, serving as the Senate President in 2011. He believed in his
32 constitutional duty to follow the rule of law and to protect Arizona's
33 citizens by enforcing those laws. He believed in standing up for the
34 taxpayers, efficiency in government and defending faith, family and
35 freedom above all else. He once wrote, "The greatness of our nation is
36 measured by the character of its people."

37 Russell Pearce is survived by his wife of 47 years, LuAnne, and
38 their children, Dodi, Sean, Colten, Justin and Joshua, Wyatt, Ethan and
39 Tatum, and many grandchildren.

40 Be it resolved by the House of Representatives of the State of Arizona,
41 the Senate concurring:

42 That the Members of the Legislature sincerely regret the passing of
43 the Honorable Russell Pearce and extend their most sincere sympathies and
44 condolences to his wife, his surviving family members and his many friends
45 and colleagues.
