HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1106

(Reference to Senate engrossed bill)

1 Page 1, line 15, strike "A SOCIAL MEDIA PLATFORM" insert "AN EMPLOYEE OF THIS  
2 STATE IN THE EMPLOYEE'S OFFICIAL CAPACITY"

3 Page 2, strike lines 5 through 12

4 Renumber to conform

5 Line 14, after "MEANS" strike remainder of line

6 Line 15, strike "OR ACCESS SOFTWARE PROVIDER" insert ". PUBLIC OR SEMIPUBLIC  
7 INTERNET-BASED SERVICE OR APPLICATION"

8 Strike lines 16 and 17

9 Renumber to conform

10 Line 21, after "\$100,000,000" insert "DIRECTLY FROM THE OPERATION OF THE  
11 SOCIAL MEDIA PLATFORM AND NOT FROM THE SELLING OF GOODS AND SERVICES"

12 Line 23, strike "OR" insert "AND"

13 Between lines 24 and 25, insert:

14 "(v) PRIMARILY FUNCTIONS TO CONNECT USERS IN ORDER TO ALLOW USERS TO  
15 INTERACT SOCIALLY WITH EACH OTHER WITHIN THE PLATFORM. EMAIL OR DIRECT  
16 MESSAGING SERVICES DOES NOT MEET THIS CRITERION ON THE BASIS OF THAT  
17 FUNCTION ALONE.

18 (vi) ALLOWS USERS TO CREATE A PUBLIC OR SEMIPUBLIC PROFILE FOR THE  
19 PURPOSES OF LOGGING IN TO AND USING THE PLATFORM, POPULATE A PUBLIC LIST OF  
20 OTHER USERS WITH WHOM AN INDIVIDUAL SHARES A SOCIAL CONNECTION WITHIN THE  
21 PLATFORM, AND POST CONTENT THAT IS VIEWABLE BY OTHER USERS."

4 Between lines 31 and 32, insert:  
5 "(c) DOES NOT INCLUDE CLOUD STORAGE, SHARED DOCUMENT COLLABORATION  
6 AND OTHER CLOUD COMPUTING SERVICES."

15 Line 15, after the first semicolon strike remainder of line  
16 Strike line 16 and 17  
17 Line 18, strike "A."  
18 Line 19, strike "OR HAS USED"  
19 Line 20, strike "CENSOR,"; strike "AND SHADOW BAN"  
20 Strike lines 22 through 44  
21 Strike pages 4 and 5, insert:  
22 "18-704. Penalties: exceptions  
23 A. AN EMPLOYEE WHO VIOLATES THIS CHAPTER SHALL BE SUBJECT TO REMOVAL  
24 FROM STATE SERVICE, REDUCTION IN GRADE, DEBARMENT FROM STATE EMPLOYMENT FOR  
25 A PERIOD NOT TO EXCEED FIVE YEARS, SUSPENSION, REPRIMAND OR A CIVIL PENALTY  
26 NOT TO EXCEED \$1,000.  
27 B. THIS CHAPTER DOES NOT PROHIBIT AN EMPLOYEE FROM ENGAGING IN  
28 LAWFUL ACTIONS WITHIN THE OFFICIAL AUTHORITY OF THE EMPLOYEE FOR THE  
29 PURPOSE OF EITHER:

- 1                   1. EXERCISING LEGITIMATE LAW ENFORCEMENT FUNCTIONS DIRECTLY RELATED
- 2                   TO ACTIVITIES TO COMBAT CHILD PORNOGRAPHY, HUMAN TRAFFICKING OR THE ILLEGAL
- 3                   TRANSPORTING OF OR TRANACTING IN CONTROLLED SUBSTANCES.
- 4                   2. SAFEGUARDING OR PREVENTING THE UNLAWFUL DISSEMINATION OF PROPERLY
- 5                   CLASSIFIED STATE SECURITY INFORMATION."
