- 1 Page 1, line 34, after "INCLUDE" insert "HEMP-DERIVED PRODUCTS,"; strike the
- 2 comma insert "OR"
- 3 Line 35, after "CONSUMPTION" insert ", INHALATION OR TOPICAL APPLICATION"
- 4 Line 43, strike "TOTAL"
- 5 Page 2, line 24, strike "or" insert a comma; after "seed" insert "OR INDUSTRIAL
- 6 HEMP PRODUCTS"
- 7 Strike lines 27 through 33
- 8 Rerumber to conform
- 9 Page 3, line 43, after "FOR" insert "MANUFACTURING,"
- 10 Line 44, after the period insert "AT A MINIMUM, RULES ADOPTED PURSUANT TO THIS
- 11 SUBSECTION SHALL REQUIRE THAT HEMP-DERIVED PRODUCTS:
 - 12 (a) BE SOLD ONLY TO INDIVIDUALS WHO ARE AT LEAST TWENTY-ONE YEARS OF
 - 13 AGE.
 - 14 (b) BE SECURELY STORED IN A MANNER THAT MAKES THE HEMP-DERIVED
 - 15 PRODUCTS NOT ACCESSIBLE TO INDIVIDUALS WHO ARE UNDER TWENTY-ONE YEARS OF
 - 16 AGE.
 - 17 (c) BE LABELED WITH A WEBSITE LINK TO OR QUICK RESPONSE CODE
 - 18 ASSOCIATED WITH THE HEMP-DERIVED PRODUCT MANUFACTURER'S WEBSITE ON THE
 - 19 HEMP-DERIVED PRODUCT'S PACKAGING THAT LINKS TO A FULL PANEL CERTIFICATE OF
 - 20 ANALYSIS PROVIDED BY AN INDEPENDENT THIRD-PARTY LABORATORY. THE CERTIFICATE
 - 21 OF ANALYSIS MUST INCLUDE:
 - 22 (i) ANALYTICAL RESULTS THAT INCLUDE TESTS FOR PESTICIDES,
 - 23 MICROBIALS, RESIDUAL SOLVENTS, HEAVY METALS AND POTENCY.

1 (ii) THE MANUFACTURER'S NAME, PHYSICAL ADDRESS, TELEPHONE NUMBER AND
2 EMAIL ADDRESS.

3 (iii) THE MANUFACTURING DATE AND BATCH NUMBER.

4 (iv) ANY OTHER INFORMATION DEEMED NECESSARY BY THE DIRECTOR."

5 Page 6, between lines 11 and 12, insert:

6 "G. DURING ANY PHYSICAL INSPECTION OF A MANUFACTURER OR RETAILER,
7 THE DIRECTOR OR THE DIRECTOR'S DESIGNEE MAY COLLECT SAMPLES OF HEMP-DERIVED
8 PRODUCTS FOR ANALYSIS BY THE STATE AGRICULTURAL LABORATORY OR A LABORATORY
9 CERTIFIED BY THE DEPARTMENT TO DETERMINE COMPLIANCE WITH THIS ARTICLE AND
10 ANY DEPARTMENT RULE AND ORDER."

11 Between lines 37 and 38, insert:

12 "Sec. 7. Section 3-318, Arizona Revised Statutes, is amended to
13 read:

14 3-318. Industrial hemp advisory council; members; duties

15 A. The director shall establish by rule or order an industrial hemp
16 advisory council to assist and make recommendations to the director
17 regarding the administration and implementation of this article. The
18 director shall appoint five members to the council, including one public
19 member.

20 B. The industrial hemp advisory council shall:

21 1. Advise the director regarding expenditures from the industrial
22 hemp trust fund.

23 2. REVIEW ALL RULES AND ORDERS ADOPTED BY THE DIRECTOR FOR THE
24 PURPOSES OF THIS ARTICLE AT LEAST ANNUALLY TO DETERMINE IF THE RULES AND
25 ORDERS CONFORM TO FEDERAL LAW AND REGULATIONS.

26 3. MAKE RECOMMENDATIONS TO THE DIRECTOR TO MAINTAIN CONFORMITY WITH
27 FEDERAL LAWS AND REGULATIONS.

29 necessary."
