4 PERSON'S DRIVING PRIVILEGE AS DESCRIBED IN SECTION 28-144 FOR:

5           1. AT LEAST NINETY DAYS AND NOT MORE THAN ONE HUNDRED EIGHTY DAYS  
6 FOR A FIRST CONVICTION PURSUANT TO THIS SUBSECTION.

7           2. ONE HUNDRED EIGHTY DAYS FOR A SECOND OR SUBSEQUENT CONVICTION  
8 PURSUANT TO THIS SUBSECTION WITHIN A PERIOD OF THIRTY-SIX MONTHS.

9           K. A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A CLASS 5 FELONY  
10 IF THE VIOLATION RESULTS IN DEATH TO A PEDESTRIAN, MOTORCYCLE OPERATOR OR  
11 BICYCLIST, AND THE PERSON IS SUBJECT TO"

16 PERSON'S DRIVING PRIVILEGE AS DESCRIBED IN SECTION 28-144 FOR:

17           1. AT LEAST ONE YEAR FOR A FIRST CONVICTION PURSUANT TO THIS  
18 SUBSECTION.

19           2. AT LEAST EIGHTEEN MONTHS FOR A SECOND OR SUBSEQUENT CONVICTION OF  
20 THIS SUBSECTION WITHIN A PERIOD OF THIRTY-SIX MONTHS."
