HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2482

(Reference to printed bill)

1 Page 1, between lines 1 and 2, insert:

2 "Section 1. Section 41-180, Arizona Revised Statutes, is amended to
3 read:

4 41-180. Law enforcement crime victim notification fund;
5 software; vendor requirement; reimbursement

6 A. The law enforcement crime victim notification fund is established
7 consisting of legislative appropriations. The state treasurer shall
8 administer the fund. Monies in the fund are subject to legislative
9 appropriation and may be used by law enforcement agencies in this state to
10 fund software that does the following:

11 1. Enables the ~~county and or city based~~ COUNTY OR CITY, OR BOTH,
12 BASED deployment of an automated crime victim notification system to a user
13 base consisting of law enforcement agencies. The automated crime victim
14 notification system must do the following:

15 (a) Automatically, and without the requirement to download a
16 software application or to opt in to notifications, notify the victim by
17 email or text of all of the following regarding a victim's law enforcement
18 crime report, investigation and case:

19 (i) The date on which the report is filed.

20 (ii) The case number.

21 (iii) The name of the detective who is assigned to the case.

22 (iv) When arrests are made.

23 (v) When warrants are issued.

24 (vi) When the case is sent to the prosecuting agency.

- 1 (vii) Initial appearance.
- 2 (b) Interface with the law enforcement agency's system of record.
- 3 (c) Provide configurable triggers to send messages to crime victims.
- 4 (d) Provide the ability to attach informational brochures or other
5 electronic attachments to the messages.
- 6 (e) Provide the ability for victims to find their case status on the
7 agency's website.
- 8 (f) Be configurable to the requirements of each county and or city
9 in this state.
- 10 (g) Include county, city or town branding, county, city or town
11 email addresses and web domains for all communications.
- 12 (h) Provide the ability to send messages in multiple languages.
- 13 (i) Provide a short code or a long code telephone number with a
14 local area code.
- 15 (j) Monitor the number of messages sent and the types of messages
16 sent and visualize the data.
- 17 2. Provides a criminal justice information service compliant
18 automated victim notification platform that ensures the following:
 - 19 (a) Crime victims are automatically notified by text and email
20 following any updates to their case.
 - 21 (b) Law enforcement agencies determine the notifications.
 - 22 (c) Crime victims are able to proactively locate their case status
23 online.
 - 24 (d) No additional staffing is required.
- 25 3. PROVIDES FOR MULTIAGENCY NOTIFICATION TO ENABLE AN AGENCY TO
26 AUTOMATICALLY SHARE THE STATUS OF AN INCIDENT OR INVESTIGATION WITH AN
27 IDENTIFIED PARTNER AGENCY BASED ON CONFIGURABLE CRITERIA.
- 28 4. PROVIDES THE CAPABILITY TO ALLOW CITIZENS TO LEVERAGE
29 CONVERSATIONAL ARTIFICIAL INTELLIGENCE FOR BIDIRECTIONAL REAL-TIME
30 COMMUNICATION WITH CITIZENS THROUGH VOICE, TEXT MESSAGES AND EMAILS. THE
31 SYSTEM SHALL PROVIDE A VIRTUAL AGENT THAT RESPONDS AND ASKS QUESTIONS BASED
32 ON THE CITIZEN'S QUESTIONS AND RESPONSES.

1 B. A vendor of any software that is described in subsection A of
2 this section must have previously deployed a solution for a city police
3 department, sheriff's office and prosecutor's office. The previously
4 deployed solutions could have been deployed in Arizona or in another state,
5 or a combination of both.

6 C. Law enforcement agencies that implement software meeting the
7 requirements of this section may submit to the state treasurer a request
8 for ~~reimbursement of~~ A GRANT FOR the software costs. ~~The state treasurer~~
9 ~~shall reimburse valid claims for reimbursement on a first-come, first-~~
10 ~~served basis.~~

11 D. A COUNTY OR CITY MAY APPLY FOR FUNDING PURSUANT TO THIS SECTION
12 FOR THREE YEARS."

19 and 2024-2025"

21 Line 10, after "Statutes" insert ", as amended by this act, for use in fiscal
22 years 2023-2024 and 2024-2025"
