10 (i) HEADQUARTERED IN CHINA, CUBA, IRAN, NORTH KOREA, RUSSIA,  
11 SAUDI ARABIA, SYRIA OR VENEZUELA.

12 (ii) DIRECTLY OR INDIRECTLY HELD OR CONTROLLED BY THE  
13 GOVERNMENT OF CHINA, CUBA, IRAN, NORTH KOREA, RUSSIA, SAUDI ARABIA,  
14 SYRIA OR VENEZUELA.

15 (iii) OWNED BY OR THE MAJORITY OF STOCK OR OTHER OWNERSHIP  
16 INTEREST OF WHICH IS HELD OR CONTROLLED BY INDIVIDUALS WHO ARE CITIZENS  
17 OF CHINA, CUBA, IRAN, NORTH KOREA, RUSSIA, SAUDI ARABIA, SYRIA OR  
18 VENEZUELA.

19 (c) A COMPANY OR OTHER ENTITY THAT IS OWNED BY OR THE MAJORITY  
20 OF STOCK OR OTHER OWNERSHIP INTEREST OF WHICH IS HELD OR CONTROLLED BY A  
21 COMPANY OR ENTITY DESCRIBED IN SUBDIVISION (b) OF THIS PARAGRAPH.

22 (d) AN INDIVIDUAL WHO IS A CITIZEN OF CHINA, CUBA, IRAN, NORTH  
23 KOREA, RUSSIA, SAUDI ARABIA, SYRIA OR VENEZUELA.
