SENATE AMENDMENTS TO S.B. 1282

1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 36, chapter 16, Arizona Revised Statutes, is  
3 amended by adding article 2, to read:

4 ARTICLE 2. CLINICAL ROTATIONS

5 36-1811. Student registered nurse anesthetists; clinical  
6 rotation program; grants; definitions

7 A. THE STUDENT REGISTERED NURSE ANESTHETIST CLINICAL ROTATION  
8 PROGRAM IS ESTABLISHED IN THE ADMINISTRATION TO EXPAND THE CAPACITY OF  
9 PRECEPTOR TRAINING PROGRAMS AT HEALTH CARE INSTITUTIONS FOR NURSE  
10 ANESTHETIST STUDENTS.

11 B. THE ADMINISTRATION SHALL DEVELOP A GRANT PROGRAM TO DISTRIBUTE  
12 MONIES APPROPRIATED FOR THE STUDENT REGISTERED NURSE ANESTHETIST CLINICAL  
13 ROTATION PROGRAM TO HEALTH CARE INSTITUTIONS THAT ARE LICENSED PURSUANT TO  
14 CHAPTER 4 OF THIS TITLE ONLY TO EXPAND OR DEVELOP CLINICAL TRAINING  
15 PLACEMENTS FOR NURSE ANESTHETIST STUDENTS, WITH PREFERENCE GIVEN TO THE  
16 EXPANSION OR DEVELOPMENT OF CLINICAL ROTATIONS IN OBSTETRICS, PEDIATRICS  
17 AND CARDIOVASCULAR CARE.

18 C. GRANT MONIES AWARDED PURSUANT TO THIS SECTION ARE INTENDED TO  
19 SUPPLEMENT AND NOT SUPPLANT EXISTING TRAINING PROGRAM EXPENSES COVERED BY  
20 THE HEALTH CARE INSTITUTION GRANTEE.

21 D. THE ADMINISTRATION SHALL ESTABLISH AN APPLICATION PROCESS FOR THE  
22 GRANT PROGRAM AND MAY AWARD GRANTS FOR MULTIYEAR PROGRAMS. THE  
23 ADMINISTRATION SHALL CONSIDER THE FOLLOWING FACTORS WHEN DETERMINING GRANT  
24 AWARDS:

25 1. THE GEOGRAPHIC AND POPULATION DISTRIBUTION.

1           2. THE NUMBER OF NURSE ANESTHETIST STUDENTS EXPECTED TO BE TRAINED  
2 AND RETAINED.

3           3. THE COST OF THE PROPOSAL FOR THE NUMBER OF NURSE ANESTHETIST  
4 STUDENTS EXPECTED TO PARTICIPATE AND BE RETAINED COMPARED TO OTHER  
5 PROPOSALS.

6           E. FOR THE PURPOSES OF THIS SECTION:

7           1. "ADMINISTRATION" MEANS THE ARIZONA HEALTH CARE COST CONTAINMENT  
8 SYSTEM ADMINISTRATION.

9           2. "HEALTH CARE INSTITUTION" HAS THE SAME MEANING PRESCRIBED IN  
10 SECTION 36-401.

11           Sec. 2. Laws 2022, chapter 330, section 3 is amended to read:

12           Sec. 3. Delayed repeal

13           Title 36, chapter 16, **ARTICLE 1**, Arizona Revised Statutes, ~~as added~~  
14 ~~by this act~~, is repealed from and after December 31, 2026.

15           Sec. 3. Appropriation; Arizona health care cost containment  
16 system administration; student registered nurse  
17 anesthetist clinical rotation program; exemption

18           A. The sum of \$200,000 is appropriated from the state general fund  
19 in fiscal year 2023-2024 to the Arizona health care cost containment system  
20 administration for the student registered nurse anesthetist clinical  
21 rotation program established by section 36-1811, Arizona Revised Statutes,  
22 as added by this act.

23           B. The appropriation made in subsection A of this section is exempt  
24 from the provisions of section 35-190, Arizona Revised Statutes, relating  
25 to lapsing of appropriations."
