4 A. THE HOMELESS SHELTER AND SERVICES FUND IS ESTABLISHED. THE
5 DEPARTMENT SHALL ADMINISTER THE FUND. MONIES IN THE FUND ARE CONTINUOUSLY
6 APPROPRIATED. THE FUND CONSISTS OF LEGISLATIVE APPROPRIATIONS, OTHER
7 MONIES DIRECTED TO BE DEPOSITED IN THE FUND AND INVESTMENT EARNINGS ON
8 MONIES IN THE FUND. ON NOTICE FROM THE DIRECTOR, THE STATE TREASURER SHALL
9 INVEST AND DIVEST MONIES IN THE FUND AS PROVIDED BY SECTION 35-313, AND
10 MONIES EARNED FROM INVESTMENT SHALL BE CREDITED TO THE FUND.

11 B. THE DEPARTMENT SHALL USE MONIES IN THE FUND TO AWARD GRANTS
12 PURSUANT TO CHAPTER 24 OF THIS TITLE TO COUNTIES, CITIES, TOWNS, INDIAN
13 TRIBES AND NONPROFIT ORGANIZATIONS FOR PROGRAMS THAT PROVIDE SHELTER AND
14 SERVICES TO UNSHELTERED PERSONS WHO ARE EXPERIENCING HOMELESSNESS.

15 C. MONIES IN THE FUND ARE EXEMPT FROM THE PROVISIONS OF SECTION
16 35-190 RELATING TO LAPSING OF APPROPRIATIONS.

17 D. ON OR BEFORE DECEMBER 31 OF EACH YEAR, THE DEPARTMENT SHALL
18 SUBMIT A REPORT TO THE GOVERNOR, THE PRESIDENT OF THE SENATE AND THE
19 SPEAKER OF THE HOUSE OF REPRESENTATIVES DESCRIBING ALL GRANTS AWARDED IN
20 THAT YEAR."

22 Page 6, strike lines 1 through 12, insert:

23 "Sec. 5. Appropriation; Arizona department of housing;
24 homeless shelter and services fund

25 A. The sum of \$145,000,000 is appropriated from the state general
26 fund in fiscal year 2023-2024 to the homeless shelter and services fund
27 established by section 41-3958, Arizona Revised Statutes, as added by this
28 act. Monies shall be used as follows:

29 1. \$70,000,000 shall be used for the purposes of section 41-3956,
30 Arizona Revised Statutes, as added by this act.

31 2. \$25,000,000 shall be used for the affordable housing
32 opportunities pilot program for cities, towns and counties in this state

1 for homeless services programs designed to reduce homelessness. Eligible
2 programs must allow homeless individuals to be compensated for daily work,
3 offer a daily remuneration rate and help participants to access support
4 services. Participating cities, towns and counties must provide a
5 dollar-for-dollar local match for each grant dollar received. The Arizona
6 department of housing shall prioritize awarding grants to cities, towns and
7 counties that have an established program that meets the grant
8 requirements.

9 3. \$50,000,000 shall be used for the purposes of section 41-710.02,
10 Arizona Revised Statutes, as added by this act.

11 B. The appropriation made in subsection A of this section is exempt
12 from the provisions of section 35-190, Arizona Revised Statutes, relating
13 to lapsing of appropriations."
