SENATE AMENDMENTS TO H.B. 2429

(Reference to House engrossed bill)

1 Page 1, line 8, strike "~~who has been convicted of an~~" insert "who has been  
2 convicted of an"

3 Line 11, after "~~34.1~~" insert "ELIGIBLE OFFENSE"

4 Between lines 24 and 25, insert:

5 "1. "ELIGIBLE OFFENSE" MEANS ANY OF THE FOLLOWING:

6 (a) AN OFFENSE THAT INVOLVES A VIOLATION OF TITLE 13, CHAPTER 34 OR  
7 34.1 OR AN OFFENSE COMMITTED IN ANOTHER JURISDICTION THAT HAS THE SAME  
8 ELEMENTS AS AN OFFENSE LISTED IN TITLE 13, CHAPTER 34 OR 34.1.

9 (b) A MISDEMEANOR OR FELONY OFFENSE UNLESS THE APPLICANT WAS  
10 CONVICTED OF A DANGEROUS OFFENSE AS DEFINED IN SECTION 13-105, A DANGEROUS  
11 CRIME AGAINST CHILDREN AS DEFINED IN SECTION 13-705 OR A SERIOUS OFFENSE OR  
12 A VIOLENT OR AGGRAVATED FELONY AS DEFINED IN SECTION 13-706.

13 (c) A MISDEMEANOR OR FELONY OFFENSE UNLESS THE APPLICANT WAS  
14 CONVICTED OF AN OFFENSE INCLUDED IN TITLE 13, CHAPTER 20, 21 OR 22 OR  
15 SECTION 13-2310 OR 13-2311 IF THE OCCUPATIONAL LICENSE IS FOR AN OCCUPATION  
16 IN WHICH THE APPLICANT WOULD OWE A FIDUCIARY DUTY TO A CLIENT.

17 (d) A MISDEMEANOR OR FELONY OFFENSE UNLESS THE APPLICANT WAS  
18 CONVICTED OF AN OFFENSE THAT THE DEPARTMENT OR AGENCY ISSUING THE  
19 OCCUPATIONAL LICENSE IS SPECIFICALLY REQUIRED TO CONSIDER BY LAW WHEN  
20 MAKING SUCH AN ISSUANCE AND THE CONVICTION HAS NOT BEEN SET ASIDE OR THE  
21 CRIMINAL HISTORY RECORD HAS NOT BEEN SEALED."
