12 AGENCIES TO ENSURE THAT NOTIFICATIONS ARE MADE IN A TIMELY AND ACCURATE  
13 MANNER.

14 7. COMPLIES WITH THE TECHNICAL GUIDELINES AND STANDARDS FOR THE  
15 OPERATION OF A STATEWIDE AUTOMATED CRIME VICTIM INFORMATION AND  
16 NOTIFICATION SYSTEM RECOMMENDED BY THE UNITED STATES DEPARTMENT OF  
17 JUSTICE'S BUREAU OF JUSTICE ASSISTANCE.

18 8. PROVIDES A DESIGNATED STATEWIDE TOLL-FREE NUMBER THAT IS  
19 AVAILABLE TWENTY-FOUR HOURS A DAY, SEVEN DAYS A WEEK, THAT IS OPERATED BY  
20 TRAINED OPERATORS AVAILABLE IN MULTIPLE LANGUAGES AND THAT ALLOWS VICTIMS,  
21 SURVIVING IMMEDIATE FAMILY MEMBERS, WITNESSES AND OTHER CONCERNED CITIZENS  
22 TO SEARCH FOR AND OBTAIN INFORMATION ABOUT AN OFFENDER, INMATE OR CASE AND  
23 TO REGISTER FOR NOTIFICATIONS."

25 Line 18, strike "this section" insert "THE VENDORS CHOSEN BY THE ARIZONA  
26 CRIMINAL JUSTICE COMMISSION TO BE PART OF THE PARTNERSHIP"

28 "C. THE ARIZONA CRIMINAL JUSTICE COMMISSION SHALL USE THE MONIES IN  
29 THE FUND TO PAY FOR LAW ENFORCEMENT AGENCIES THAT CHOOSE TO USE THE  
30 AUTOMATED CRIME VICTIM NOTIFICATION SYSTEM.

1 D. FOR THE PURPOSES OF THIS SECTION, "LAW ENFORCEMENT AGENCY"  
2 INCLUDES A STATE, CITY, TOWN, COUNTY, TRIBAL, UNIVERSITY OR PROSECUTORIAL  
3 AGENCY.

4 Sec. 2. Sexual assault kit study committee; membership;  
5 duties; report; delayed repeal

6 A. The sexual assault kit study committee is established consisting  
7 of the following members appointed by the speaker of the house of  
8 representatives:

9 1. Five members of the house of representatives, not more than three  
10 of whom are members of the same political party. The speaker of the house  
11 of representatives shall designate one of these members to serve as  
12 chairperson of the committee.

13 2. Two county sheriffs or their appointees.

14 3. One police chief or the police chief's appointee.

15 4. One county attorney or the county attorney's appointee.

16 5. One representative of a group that represents victims' rights.

17 B. Appointed members serve at the pleasure of the speaker of the  
18 house of representatives.

19 C. Committee members are not eligible to receive compensation.

20 D. The committee shall:

21 1. Meet as often as the chairperson deems necessary.

22 2. Examine the feasibility of providing crime victims with a  
23 tracking system for sexual assault forensic examination kits.

24 3. On or before December 1, 2023, submit a report of its findings  
25 and recommendations to the speaker of the house of representatives and the  
26 president of the senate and provide a copy of this report to the secretary  
27 of state.

28 E. This section is repealed from and after September 30, 2024.

29 Sec. 3. Arizona criminal justice commission; crime victim  
30 notification system; delayed repeal

31 A. Notwithstanding section 41-2414, Arizona Revised Statutes, as  
32 amended by this act, in fiscal years 2023-2024, 2024-2025 and 2025-2026 the

1 Arizona criminal justice commission shall include a partnership between at  
2 least two vendors for the purpose of expanding the Arizona criminal justice  
3 commission's automated crime victim notification system as required by  
4 solicitation number BPM003618.

5 B. This section is repealed from and after December 31, 2026."
