SENATE AMENDMENTS TO H.B. 2509
(Reference to House engrossed bill)

1 Page 10, between lines 5 and 6, insert:

2 "B. IF A COTTAGE FOOD PRODUCT IS OFFERED FOR SALE ONLINE, THE ONLINE
3 PLATFORM MUST PROVIDE A NOTIFICATION THAT INCLUDES ALL OF THE FOLLOWING:
4 1. THE NAME AND REGISTRATION NUMBER OF THE FOOD PREPARER.
5 2. A LIST OF ALL INGREDIENTS IN THE COTTAGE FOOD PRODUCT AND THE
6 COTTAGE FOOD PRODUCT'S PRODUCTION DATE.

7 3. THE FOLLOWING STATEMENT: "THIS PRODUCT WAS PRODUCED IN A HOME
8 KITCHEN THAT MAY PROCESS COMMON FOOD ALLERGENS AND IS NOT SUBJECT TO PUBLIC
9 HEALTH INSPECTION.""

10 Reletter to conform

11 Line 13, strike "PRODUCER" insert "PREPARER:

12 1."

13 Between lines 14 and 15, insert:

14 "2. MAY NOT STORE COTTAGE FOOD PRODUCTS OR FOOD PREPARATION
15 EQUIPMENT OUTSIDE OF THE FOOD PREPARER'S HOME."

16 Between lines 35 and 36, insert:

17 "F. A COTTAGE FOOD PRODUCT MAY NOT:

18 1. BE USED AS AN INGREDIENT IN FOOD PRODUCTS SOLD AT A PERMITTED
19 RETAIL FOOD ESTABLISHMENT.

20 2. INCLUDE MARIJUANA OR MARIJUANA BY-PRODUCTS.

21 G. A COTTAGE FOOD PRODUCT SHALL CONTAIN ONLY INGREDIENTS THAT ARE
22 FROM SOURCES THAT ARE APPROVED BY LAW.

23 H. A HOME KITCHEN THAT IS USED TO PREPARE COTTAGE FOOD PRODUCTS MAY
24 NOT OPERATE AS A COMMISSARY FOR THE PURPOSES OF SECTION 36-1761."

Senate Amendments to H.B. 2509

- 1 Page 10, line 39, strike "OR A COUNTY"
- 2 Line 40, after "ANY" insert "REPORTED"
- 3 After line 44, insert:
 - 4 "4. DOES NOT AFFECT ANY COUNTY OR MUNICIPAL BUILDING CODE, ZONING
 - 5 CODE OR ORDINANCE OR OTHER LAND USE REGULATION."
- 6 Page 11, line 2, after "PRODUCTS" insert "THAT ARE"; strike the period insert
7 "AND THAT INCLUDE BOTH OF THE FOLLOWING:
 - 8 1. A PROVISION REQUIRING SUSPENSION OR REVOCATION OF AN INDIVIDUAL'S
 - 9 REGISTRATION FOR FAILING TO COMPLY WITH THE REQUIREMENTS OF THIS ARTICLE OR
 - 10 IMPEDING IN THE INVESTIGATION OF A REPORTED FOODBORNE ILLNESS.
 - 11 2. GUIDANCE RELATING TO APPROVED INGREDIENT SOURCES."
- 12 Between lines 3 and 4, insert:
 - 13 "D. A COUNTY MAY NOT BE REQUIRED TO ENFORCE THIS ARTICLE.
 - 14 E. THIS ARTICLE DOES NOT PREVENT THE DEPARTMENT AND A LOCAL HEALTH
 - 15 AGENCY, ENVIRONMENTAL AGENCY OR PUBLIC HEALTH SERVICES AGENCY FROM ENTERING
 - 16 INTO A DELEGATION AGREEMENT TO ENFORCE THIS ARTICLE."
- 17 Amend title to conform
