# **HOUSE BILL 2112**

AN ACT

AMENDING TITLE 20, CHAPTER 4, ARTICLE 9, ARIZONA REVISED STATUTES, BY ADDING SECTION 20-1057.20; RELATING TO HEALTH CARE SERVICES ORGANIZATIONS.

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Title 20, chapter 4, article 9, Arizona Revised  
3 Statutes, is amended by adding section 20-1057.20, to read:

4           20-1057.20. Hearing aids; evidences of coverage; children;  
5           definitions

6       A. A HEALTH CARE SERVICES ORGANIZATION THAT ISSUES, AMENDS,  
7 DELIVERS OR RENEWS AN EVIDENCE OF COVERAGE SHALL PROVIDE COVERAGE FOR A  
8 HEARING AID AND ANY RELATED SERVICE FOR THE FULL COST OF ONE HEARING AID  
9 PER HEARING IMPAIRED EAR UP TO \$2,200 EVERY THIRTY-SIX MONTHS FOR AN  
10 ENROLLEE WHO IS UNDER EIGHTEEN YEARS OF AGE OR WHO IS UNDER TWENTY-ONE  
11 YEARS OF AGE IF THE ENROLLEE IS STILL ATTENDING HIGH SCHOOL. THE ENROLLEE  
12 MAY CHOOSE A HIGHER PRICED HEARING AID AND MAY PAY THE DIFFERENCE IN COST  
13 ABOVE THE \$2,200 LIMIT WITHOUT FINANCIAL OR CONTRACTUAL PENALTY TO THE  
14 ENROLLEE OR THE PROVIDER OF THE HEARING AID.

15     B. A HEALTH CARE SERVICES ORGANIZATION MAY MAKE AVAILABLE TO THE  
16 ENROLLEE THE OPTION OF PURCHASING ADDITIONAL HEARING AID COVERAGE THAT  
17 EXCEEDS THE SERVICES DESCRIBED IN THIS SECTION.

18     C. THE HEARING AID COVERAGE SHALL INCLUDE FITTING AND DISPENSING  
19 SERVICES, PROVIDING EAR MOLDS, AS NECESSARY TO MAINTAIN OPTIMAL FIT, AND  
20 ANY RELATED SERVICES AS PROVIDED BY A LICENSED HEALTH CARE PROVIDER.

21     D. THIS SECTION DOES NOT APPLY TO SHORT-TERM TRAVEL, ACCIDENT-ONLY  
22 OR LIMITED BENEFIT COVERAGE AS DEFINED IN SECTION 20-1137.

23     E. COVERAGE FOR HEARING AIDS MAY BE SUBJECT TO DEDUCTIBLES AND  
24 COINSURANCE CONSISTENT WITH THOSE IMPOSED ON OTHER BENEFITS UNDER THE SAME  
25 EVIDENCE OF COVERAGE.

26     F. FOR THE PURPOSES OF THIS SECTION:

27       1. "HEARING AID" MEANS DURABLE MEDICAL EQUIPMENT THAT IS OF A  
28 DESIGN AND CIRCUITRY TO OPTIMIZE AUDIBILITY AND LISTENING SKILLS IN THE  
29 ENVIRONMENT COMMONLY EXPERIENCED BY CHILDREN.

30       2. "LICENSED HEALTH CARE PROVIDER" MEANS A PHYSICIAN WHO IS  
31 LICENSED PURSUANT TO TITLE 32, CHAPTER 13 OR 17, AN AUDIOLOGIST WHO IS  
32 LICENSED PURSUANT TO TITLE 36, CHAPTER 17 AND A HEARING AID DISPENSER WHO  
33 IS LICENSED PURSUANT TO TITLE 36, CHAPTER 17.

34     Sec. 2. Applicability

35     Section 20-1057.20, Arizona Revised Statutes, as added by this act,  
36 applies to evidences of coverage issued with an effective date on or after  
37 December 31, 2024.
