### **AN ACT**

AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-500.50; AMENDING TITLE 11, CHAPTER 3, ARTICLE 2, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-459.02; AMENDING TITLE 41, CHAPTER 12, ARTICLE 3, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-1757; RELATING TO LAW ENFORCEMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes,  
3 is amended by adding section 9-500.50, to read:

4 9-500.50. Traffic complaint quota; determination of rank  
5 based on traffic complaints; prohibition

6 A MUNICIPALITY OR POLICE DEPARTMENT MAY NOT ESTABLISH A TRAFFIC  
7 COMPLAINT QUOTA FOR PEACE OFFICERS EMPLOYED BY THE POLICE DEPARTMENT, BASE  
8 THE DETERMINATION OF A PEACE OFFICER'S RANK ON THE NUMBER OF TRAFFIC  
9 COMPLAINTS THE PEACE OFFICER ISSUES OR CONSIDER AS A FACTOR THE NUMBER OF  
10 TRAFFIC COMPLAINTS A PEACE OFFICER ISSUES WHEN DETERMINING THE PEACE  
11 OFFICER'S RANK.

17 COMPLAINT QUOTA FOR PEACE OFFICERS EMPLOYED BY THE SHERIFF'S DEPARTMENT,  
18 BASE THE DETERMINATION OF A PEACE OFFICER'S RANK ON THE NUMBER OF TRAFFIC  
19 COMPLAINTS THE PEACE OFFICER ISSUES OR CONSIDER AS A FACTOR THE NUMBER OF  
20 TRAFFIC COMPLAINTS A PEACE OFFICER ISSUES WHEN DETERMINING THE PEACE  
21 OFFICER'S RANK.
