# SENATE BILL 1073

AN ACT

AMENDING SECTION 13-2906, ARIZONA REVISED STATUTES; RELATING TO OFFENSES  
AGAINST PUBLIC ORDER.

1 Be it enacted by the Legislature of the State of Arizona:  
2 Section 1. Section 13-2906, Arizona Revised Statutes, is amended to  
3 read:  
4 13-2906. Obstructing a highway or other public thoroughfare;  
5 classification; definition  
6 A. A person commits obstructing a highway or other public  
7 thoroughfare if the person, alone or with other persons, does any of the  
8 following:  
9 1. Having no legal privilege to do so, recklessly interferes with  
10 the passage of any highway or public thoroughfare by creating an  
11 unreasonable inconvenience or hazard.  
12 2. Intentionally activates a pedestrian signal on a highway or  
13 public thoroughfare if the person's reason for activating the signal is  
14 not to cross the highway or public thoroughfare but to do both of the  
15 following:  
16 (a) Stop the passage of traffic on the highway or public  
17 thoroughfare.  
18 (b) Solicit a driver for a donation or business.  
19 3. After receiving a verbal warning to desist, intentionally  
20 interferes with passage on a highway or other public thoroughfare or  
21 entrance into a public forum that results in preventing other persons from  
22 gaining access to a governmental meeting, a governmental hearing or a  
23 political campaign event.  
24 4. ~~HAVING NO LEGAL PRIVILEGE TO DO SO AND AFTER RECEIVING A VERBAL~~  
25 ~~WARNING TO DESIST, INTENTIONALLY INTERFERES WITH PASSAGE ON ANY ROADWAY IN~~  
26 ~~OR LEADING TO AN AIRPORT OR PASSAGE ON A HIGHWAY, BRIDGE OR TUNNEL~~  
27 ~~CURRENTLY HOLDING TWENTY-FIVE OR MORE VEHICLES OR PEOPLE.~~  
28 B. Obstructing a highway or other public thoroughfare under:  
29 1. ~~SUBSECTION A, PARAGRAPH 4 OF THIS SECTION IS A CLASS 6 FELONY.~~  
30 ~~1.~~ 2. Subsection A, paragraph 3 of this section is a class 1  
31 misdemeanor.  
32 ~~2.~~ 3. Subsection A, paragraph 1 of this section is a class 2  
33 misdemeanor, except that a second or subsequent violation within a period  
34 of twenty-four months is a class 1 misdemeanor.  
35 ~~3.~~ 4. Subsection A, paragraph 2 of this section is a class 3  
36 misdemeanor.  
37 C. For the purposes of this section, "public forum" has the same  
38 meaning prescribed in section 15-1861.
