AN ACT

AMENDING TITLE 15, CHAPTER 13, ARTICLE 2, ARIZONA REVISED STATUTES, BY
ADDING SECTION 15-1650.07; RELATING TO THE ARIZONA BOARD OF REGENTS.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 15, chapter 13, article 2, Arizona Revised
3 Statutes, is amended by adding section 15-1650.07, to read:
4 15-1650.07. Grade challenge board; political bias; appeals;
5 definition
6 A. THE GRADE CHALLENGE DEPARTMENT IS ESTABLISHED WITHIN THE ARIZONA
7 BOARD OF REGENTS. THE GRADE CHALLENGE DEPARTMENT SHALL HAVE A LOCATION AT
8 EACH PUBLIC UNIVERSITY AND SHALL HEAR CHALLENGES FROM PUBLIC UNIVERSITY
9 STUDENTS REGARDING GRADES RECEIVED IN ANY CLASS OR ON ANY ASSIGNMENT IF A
10 STUDENT ALLEGES A GRADE WAS AWARDED BECAUSE OF POLITICAL BIAS.
11 B. THE GRADE CHALLENGE DEPARTMENT SHALL BE COMPOSED OF VOLUNTEERS
12 SELECTED BY THE ARIZONA BOARD OF REGENTS TO PROVIDE A HEARING FOR PUBLIC
13 UNIVERSITY STUDENTS TO CHALLENGE A GRADE AWARDED ON AN ASSIGNMENT OR AN
14 OVERALL CLASS GRADE. THE BOARD SHALL PROVIDE STAFF TO SUPPORT THE
15 DEPARTMENT AS NECESSARY.
16 C. IF THE GRADE CHALLENGE DEPARTMENT DETERMINES THAT A STUDENT'S
17 GRADE WAS AWARDED BECAUSE OF POLITICAL BIAS, THE DEPARTMENT MAY REQUIRE
18 ANY FACULTY MEMBER OF A PUBLIC UNIVERSITY TO REGRADE THE STUDENT'S
19 ASSIGNMENT OR REEVALUATE THE STUDENT'S OVERALL CLASS GRADE CONSISTENT WITH
20 THE DEPARTMENT'S GUIDANCE.
21 D. IF A STUDENT BELIEVES THE GRADE CHALLENGE DEPARTMENT WRONGLY
22 DISMISSED THE STUDENT'S CHALLENGE OR DID NOT ADEQUATELY CONSIDER THE FACTS
23 OF THE CHALLENGE, THE STUDENT MAY APPEAL THE DECISION OF THE DEPARTMENT TO
24 THE ARIZONA BOARD OF REGENTS. THE BOARD MAY ORDER ANY FACULTY MEMBER OF A
25 PUBLIC UNIVERSITY TO REGRADE A STUDENT'S ASSIGNMENT OR REEVALUATE A
26 STUDENT'S OVERALL CLASS GRADE CONSISTENT WITH THE BOARD'S GUIDANCE.
27 E. FOR THE PURPOSES OF THIS SECTION, "PUBLIC UNIVERSITY" MEANS A
28 UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF REGENTS.
