(Reference to Senate engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 21-101, Arizona Revised Statutes, is amended to
3 read:

4 21-101. Definitions

5 In this title, unless the context otherwise requires:

6 1. "Juror pool" means the persons who are summoned and who report on
7 a specific date to or for a specific location for either trial or grand
8 jury service.

9 2. "Jury commissioner" means the clerk of the superior court, except
10 that in any county having a population of more than five hundred thousand
11 persons, the presiding judge of the superior court may appoint a jury
12 commissioner.

13 3. "Jury manager" means the person who is responsible for jury
14 management in a justice of the peace court or a municipal court.

15 4. "Jury panel" means a group of jurors who are drawn at random from
16 the juror pool and who are assigned to a specific case or trial.

17 5. "Master jury file" means a list of prospective jurors who are
18 randomly selected from the master jury list.

19 6. "Master jury list":

20 (a) Means a record of the names, ~~and~~ addresses, DATES OF BIRTH AND,
21 IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of eligible persons who
22 reside in the county. ~~and~~

1 (b) Includes persons on the voter registration list of the county
2 and other persons who are eligible for jury service and who have been
3 licensed pursuant to title 28, chapter 8, article 4 or 5.

4 Sec. 2. Section 21-301, Arizona Revised Statutes, is amended to
5 read:

6 21-301. Master jury list; source lists

7 A. The jury commissioner shall produce a master jury list. The
8 master jury list shall be comprised of the names, ~~and~~ addresses, DATES OF
9 BIRTH AND, IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of eligible
10 persons who reside in the county and shall include persons on the voter
11 registration list of the county, other persons eligible for jury service
12 who have been licensed pursuant to title 28, chapter 8, article 4 or 5 and
13 persons from other lists as determined by the supreme court. The master
14 jury list shall be prepared so as to avoid duplication of the names of
15 eligible juror candidates.

16 B. Not later than January 1 following each biennial general
17 election, the county recorder shall provide the jury commissioner or jury
18 manager with a list containing the names, ~~and~~ addresses, DATES OF BIRTH
19 AND, IF AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all persons WHO
20 ARE qualified to vote at the preceding general election. At least once
21 every six months thereafter the county recorder shall provide the jury
22 commissioner with the names, ~~and~~ addresses, DATES OF BIRTH AND, IF
23 AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all additional persons
24 who have registered as voters since the date of the last list.

25 C. On written request by a jury commissioner or jury manager, the
26 director of the department of transportation shall furnish and periodically
27 revise a list of the names, ~~and~~ addresses, DATES OF BIRTH AND, IF
28 AVAILABLE, TELEPHONE NUMBERS AND EMAIL ADDRESSES of all persons in that
29 county who are at least eighteen years of age and who have been licensed
30 pursuant to title 28, chapter 8, article 4 or 5. Except as provided in
31 section 21-312, ~~no~~ A jury commissioner or jury manager may NOT disclose
32 information furnished by the director of the department of transportation

1 pursuant to this section to any person, organization or agency for any use
2 other than the selection of jurors."
