4 PROTECTION SYSTEM CARRIED OUT PURSUANT TO A BUILDING CODE OR FIRE CODE THAT
5 IS ADOPTED BY A CITY OR TOWN SHALL BE PERFORMED IN ACCORDANCE WITH THE
6 STANDARDS ESTABLISHED BY A NATIONALLY RECOGNIZED STANDARDS DEVELOPING

16 IS ADOPTED BY A COUNTY SHALL BE PERFORMED IN ACCORDANCE WITH THE STANDARDS
17 ESTABLISHED BY A NATIONALLY RECOGNIZED STANDARDS DEVELOPING ORGANIZATION.
