- 5 Page 9, line 23, after "INSTALL" strike remainder of line
- 6 Strike lines 24 through 42
- 7 Page 10, strike lines 1 through 4, insert "ON THE DEALER'S DEALERSHIP PREMISES A
8 CUSTOMER FACING ELECTRIC VEHICLE CHARGING STATION ACCESSIBLE TO THE GENERAL

12 AVAILABLE OR PAY INCENTIVES OR OTHER BENEFITS TO A DEALER THAT HAS NOT
13 SATISFIED THE REQUIREMENTS FOR ELIGIBILITY ON THE SAME TERMS THAT ARE
14 APPLIED UNIFORMLY AND EQUITABLY TO ALL DEALERS OF THE SAME LINE-MAKE IN
15 THIS STATE."

- 18 Line 38, strike "FROM A DEALER" insert "ON THE SAME TERMS AS OFFERED TO OTHER
19 DEALERS OF THE SAME LINE-MAKE IN THIS STATE"; strike "CHARGING" insert
20 "OFFERING"
- 21 Line 39, after "PARTS" insert "THAN IS OFFERED TO OTHER SAME LINE-MAKE DEALERS
22 IN THIS STATE"; after "PROVIDING" insert "THE OPPORTUNITY TO EARN"; after
23 "INCENTIVES" insert "ON THE SAME TERMS AS OTHER SAME LINE-MAKE DEALERS IN
24 THIS STATE"

1 Page 11, between lines 40 and 41, insert:

2 "3. DOES NOT INCLUDE REQUIRED COMPLIANCE WITH A MANUFACTURER'S,
3 IMPORTER'S OR DISTRIBUTOR'S REASONABLY NECESSARY STANDARDS AND REQUIREMENTS
4 TO FULFILL THE DEALER'S SALES AND SERVICE OBLIGATIONS."

5 Page 20, after line 27, insert:

6 "Sec. 5. Title 28, chapter 10, article 5, Arizona Revised Statutes,
7 is amended by adding section 28-4464, to read:

8 28-4464. Applicability

9 THIS ARTICLE DOES NOT APPLY TO A MANUFACTURER THAT DOES NOT AND HAS
10 NEVER USED FRANCHISED NEW MOTOR VEHICLE DEALERS TO OFFER, SELL OR SERVICE
11 NEW MOTOR VEHICLES THAT ARE MANUFACTURED OR DISTRIBUTED BY A FRANCHISOR,
12 MANUFACTURER, IMPORTER OR DISTRIBUTOR."
