1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 13-3553, Arizona Revised Statutes, is amended to  
3 read:

4 13-3553. Sexual exploitation of a minor; evidence;  
5 classification; definition

6 A. A person commits sexual exploitation of a minor by knowingly:

7 1. Recording, filming, photographing, developing or duplicating any  
8 visual depiction in which a minor is engaged in exploitive exhibition or  
9 other sexual conduct.

10 2. Distributing, transporting, exhibiting, receiving, selling,  
11 purchasing, electronically transmitting, possessing or exchanging any  
12 visual depiction in which a minor is engaged in exploitive exhibition or  
13 other sexual conduct.

14 3. PRODUCING, PUBLISHING, ALTERING OR GENERATING WITH ARTIFICIAL  
15 INTELLIGENCE ANY VISUAL DEPICTION IN WHICH A MINOR IS ENGAGED IN EXPLOITIVE  
16 EXHIBITION OR OTHER SEXUAL CONDUCT.

17 4. POSSESSING, PRODUCING, PUBLISHING, DISTRIBUTING, OFFERING TO  
18 SELL, SELLING, PURCHASING OR GENERATING WITH ARTIFICIAL INTELLIGENCE ANY  
19 VISUAL DEPICTION THAT USES THE FACE, IMAGE OR LIKENESS OF A REAL MINOR WHO  
20 IS UNDER TWELVE YEARS OF AGE AND WHO IS ENGAGED IN EXPLOITIVE EXHIBITION OR  
21 OTHER SEXUAL CONDUCT WITH THE INTENT TO REPLICATE THE PHYSICAL FEATURES OF  
22 THAT REAL MINOR WHO IS UNDER TWELVE YEARS OF AGE.

1           **3-** 5. Possessing, manufacturing, distributing, advertising,  
2 ordering, offering to sell, selling or purchasing a child sex doll that  
3 uses the face, image or likeness of a real infant or minor who is under  
4 twelve years of age with the intent to replicate the physical features of  
5 **the THAT** real infant or minor who is under twelve years of age.

6           B. If any visual depiction of sexual exploitation of a minor is  
7 admitted into evidence, the court shall seal that evidence at the  
8 conclusion of any grand jury proceeding, hearing or trial.

9           C. Sexual exploitation of a minor is a class 2 felony and if the  
10 minor is under fifteen years of age it is punishable pursuant to section  
11 13-705.

12           D. For the purposes of this section, "child sex doll" has the same  
13 meaning prescribed in section 13-1429."
