1 Page 3, between lines 13 and 14, insert:

2 "Sec. 3. Section 28-2432, Arizona Revised Statutes, is amended to  
3 read:

4 28-2432. Arizona professional basketball clubs special plates;  
5 fund

6 A. ~~If, by December 31, 2008, a charitable organization affiliated~~  
7 ~~with an Arizona professional basketball club donates thirty-two thousand~~  
8 ~~dollars to the veterans' donations fund established by section 41-608 for~~  
9 ~~the purpose of paying the implementation costs of the gold star family~~  
10 ~~special plates established by section 28-2431 and the thirty-two thousand~~  
11 ~~dollars is paid to the department for the implementation of this section,~~  
12 The department shall issue Arizona professional basketball ~~club~~ CLUBS  
13 special plates IN TWO DIFFERENT DESIGNS AS FOLLOWS:

14 1. ON OR BEFORE DECEMBER 31, 2024, the entity that provides the  
15 ~~thirty-two thousand dollars~~ \$32,000 for the implementation of the Arizona  
16 professional basketball ~~club~~ CLUBS special plates shall design the Arizona  
17 professional MEN'S basketball club special plates. The design and color of  
18 the Arizona professional MEN'S basketball club special plates are subject  
19 to the approval of the department.

20 2. IF, BY DECEMBER 31, 2024, A PERSON PROVIDES AN ADDITIONAL \$32,000  
21 TO THE DEPARTMENT FOR THE ARIZONA PROFESSIONAL BASKETBALL CLUBS SPECIAL  
22 PLATES, THE PERSON THAT PROVIDES THE \$32,000 SHALL DESIGN THE ARIZONA

1 PROFESSIONAL WOMEN'S BASKETBALL CLUB SPECIAL PLATES. THE DESIGN AND COLOR  
2 OF THE ARIZONA PROFESSIONAL WOMEN'S BASKETBALL CLUB SPECIAL PLATES ARE  
3 SUBJECT TO THE APPROVAL OF THE DEPARTMENT.

4 B. ALL OF THE FOLLOWING APPLY TO THE ARIZONA PROFESSIONAL BASKETBALL  
5 CLUBS SPECIAL PLATES ISSUED PURSUANT TO SUBSECTION A OF THIS SECTION:

6 1. The director may allow a request for Arizona professional  
7 basketball ~~club~~ CLUBS special plates to be combined with a request for  
8 personalized special plates. If the director allows such a combination,  
9 the request shall be in a form prescribed by the director and is subject to  
10 the fees for the personalized special plates in addition to the fees  
11 required for Arizona professional basketball ~~club~~ CLUBS special plates.

12 ~~B.~~ 2. Of the ~~twenty-five-dollar~~ \$25 fee required by section 28-2402  
13 for the original special plates and for renewal of special plates, ~~eight~~  
14 ~~dollars~~ \$8 is a special plate administration fee and ~~seventeen-dollars~~ \$17  
15 is an annual donation.

16 ~~C.~~ 3. The department shall deposit, pursuant to sections 35-146 and  
17 35-147, all special plate administration fees in the state highway fund  
18 established by section 28-6991 and all donations collected pursuant to this  
19 section in the Arizona professional basketball ~~club~~ CLUBS special plate  
20 fund established by subsection ~~B~~ C of this section.

21 ~~B.~~ C. The Arizona professional basketball ~~club~~ CLUBS special plate  
22 fund is established consisting of monies received pursuant to this section.  
23 The director shall administer the fund. The first ~~thirty-two-thousand~~  
24 ~~dollars~~ \$32,000 received PURSUANT TO SUBSECTION A, PARAGRAPH 1 OF THIS  
25 SECTION shall be reimbursed to the entity that paid the implementation fee  
26 to the department ~~pursuant to subsection A of this section~~ AND THE FIRST  
27 \$32,000 RECEIVED PURSUANT TO SUBSECTION A, PARAGRAPH 2 OF THIS SECTION  
28 SHALL BE REIMBURSED TO THE PERSON THAT PAID THE IMPLEMENTATION FEE TO THE  
29 DEPARTMENT. Not more than ten ~~per-cent~~ PERCENT of monies deposited in the  
30 fund annually shall be used for the cost of administering the fund. Monies

1 in the fund are continuously appropriated. The director shall allocate  
2 monies from the fund through a private Arizona professional basketball  
3 organization's foundation that is qualified under section 501(c)(3) of the  
4 United States internal revenue code for federal income tax purposes. The  
5 director shall forward all monies deposited in the Arizona professional  
6 basketball ~~club~~ CLUBS special plate fund, excluding administrative fees, to  
7 the foundation on an annual basis.

8 ~~E.~~ D. On notice from the director, the state treasurer shall invest  
9 and divest monies in the fund as provided by section 35-313, and monies  
10 earned from investment shall be credited to the fund.

11 Sec. 4. Section 28-2470.18, Arizona Revised Statutes, is amended to  
12 read:

13 28-2470.18. Gila River Indian community special plates

14 A. If by December 31, ~~2023~~ 2024, a person pays \$32,000 to the  
15 department for the implementation of this section, the department shall  
16 issue Gila River Indian community special plates. The person that provides  
17 the \$32,000 shall design the Gila River Indian community special plates.  
18 The design and color of the Gila River Indian community special plates are  
19 subject to the approval of the department. The director may allow a  
20 request for Gila River Indian community special plates to be combined with  
21 a request for personalized special plates. If the director allows such a  
22 combination, the request shall be in a form prescribed by the director and  
23 is subject to the fees for the personalized special plates in addition to  
24 the fees required for the Gila River Indian community special plates.

25 B. Of the \$25 fee required by section 28-2402 for the original  
26 special plates and for renewal of special plates, \$8 is a special plate  
27 administration fee and \$17 is an annual donation.

28 C. The department shall deposit, pursuant to sections 35-146 and  
29 35-147, all special plate administration fees in the state highway fund  
30 established by section 28-6991 and shall transmit all donations collected

1       pursuant to this section to the Gila River Indian community transportation  
2       committee. The Gila River Indian community transportation committee shall  
3       use these monies only for traffic control devices that conform to the  
4       manual and specifications prescribed in section 28-641 on highways on the  
5       Gila River Indian reservation that are located in this state and that are  
6       not state highways."
