- 2 Line 12, strike "forty-five" insert "SEVENTY-ONE"
- 3 Strike line 16, insert "the"
- 4 Line 17, after the period insert "FOR A SIGN THAT SUPPORTS OR OPPOSES A BALLOT
MEASURE, QUESTION OR ISSUE, THIS SUBSECTION APPLIES ONLY FOR THE ELECTION
AT WHICH THE BALLOT MEASURE, QUESTION OR ISSUE IS SCHEDULED TO APPEAR ON
THE BALLOT AND FOR THE PERIOD COMMENCING SEVENTY-ONE DAYS BEFORE THAT
ELECTION AND ENDING FIFTEEN DAYS AFTER THAT ELECTION."

MEASURE, QUESTION OR ISSUE, SUBSECTION C OF THIS SECTION APPLIES ONLY FOR
THE ELECTION AT WHICH THE BALLOT MEASURE, QUESTION OR ISSUE IS SCHEDULED TO
APPEAR ON THE BALLOT AND FOR THE PERIOD COMMENCING SEVENTY-ONE DAYS BEFORE
THAT ELECTION AND ENDING FIFTEEN DAYS AFTER THAT ELECTION."

 - 19 1. "GENERAL OR RUNOFF ELECTION" MEANS:
 - 20 (a) THE GENERAL ELECTION AS PRESCRIBED BY SECTION 16-211 AND, FOR A
21 CITY OR TOWN OR OTHER POLITICAL SUBDIVISION THAT HOLDS A PRIMARY OR FIRST
22 ELECTION, THE RUNOFF ELECTION OR SECOND ELECTION WITHOUT REGARD TO WHETHER
23 THE POLITICAL SUBDIVISION DESIGNATES THE ELECTION AS A GENERAL, RUNOFF OR
24 SECOND ELECTION OR ANY OTHER DESCRIPTIVE TERM.

1 (b) FOR A POLITICAL SUBDIVISION THAT HOLDS A SINGLE ELECTION AND FOR
2 WHICH A PRIMARY ELECTION IS NEVER HELD, THE SINGLE ELECTION.

3 2. "POLITICAL SUBDIVISION" MEANS A CITY, TOWN, COUNTY, SCHOOL
4 DISTRICT, SPECIAL TAXING DISTRICT OR OTHER GOVERNMENTAL ENTITY.

5 3. "PRIMARY OR FIRST ELECTION" MEANS AN ELECTION THAT IS HELD AS
6 PRESCRIBED BY SECTION 16-201 AND, FOR A CITY OR TOWN OR OTHER POLITICAL
7 SUBDIVISION THAT HOLDS A PRELIMINARY, PRIMARY OR FIRST ELECTION THAT IS
8 HELD FOR THE PURPOSE OF REDUCING THE NUMBER OF CANDIDATES FOR A POSSIBLE
9 SUBSEQUENT ELECTION OR RECEIVING A PARTISAN NOMINATION OR DESIGNATION,
10 WITHOUT REGARD TO WHETHER THE POLITICAL SUBDIVISION DESIGNATES THE ELECTION
11 A PRIMARY ELECTION, A FIRST ELECTION, A PRELIMINARY ELECTION OR ANY OTHER
12 DESCRIPTIVE TERM."
