7 (i) A COMMERCIAL LIVESTOCK AUCTION MARKET.

8 (ii) A CHARITABLE NONPROFIT RESCUE OR HUMANE SOCIETY OR ANY ANIMAL
9 ADOPTION ACTIVITY THAT A RESCUE OR HUMANE SOCIETY CONDUCTS OFF-SITE AT ANY
10 PET STORE OR OTHER COMMERCIAL ENTERPRISE."
