4 **(a) MEANS A COMMERCIAL ESTABLISHMENT THAT ENGAGES IN A FOR-PROFIT**
5 **BUSINESS THAT SELLS CATS, DOGS OR OTHER ANIMALS IN A RETAIL SETTING.**

6 **(b) DOES NOT INCLUDE EITHER OF THE FOLLOWING:**

7 **(i) A COMMERCIAL LIVESTOCK AUCTION MARKET.**

8 **(ii) A CHARITABLE NONPROFIT RESCUE OR HUMANE SOCIETY OR ANY ANIMAL**
9 **ADOPTION ACTIVITY THAT A RESCUE OR HUMANE SOCIETY CONDUCTS OFF-SITE AT ANY**
