1 Page 1, lines 19 and 20, strike "COURT OF RECORD OR A VENDOR THAT IS CONTRACTED
2 BY THE COURT" insert "ADMINISTRATIVE OFFICE OF THE COURTS OR ITS CONTRACTED
3 VENDOR"

4 Strike line 25

5 Line 26, strike "CONTRACTED BY THE COURT shall transmit"; strike "promptly"
6 insert "SHALL BE TRANSMITTED"

7 Lines 41 and 42, strike "COURT OF RECORD OR A VENDOR THAT IS CONTRACTED BY THE
8 COURT" insert "ADMINISTRATIVE OFFICE OF THE COURTS OR ITS CONTRACTED
9 VENDOR"

10 Page 2, lines 1 and 2, strike "COURT OF RECORD OR A VENDOR THAT IS CONTRACTED BY
11 THE COURT" insert "ADMINISTRATIVE OFFICE OF THE COURTS OR ITS CONTRACTED
12 VENDOR"

13 Line 7, strike "DO BOTH OF THE FOLLOWING"

14 Between lines 10 and 11, insert:

15 "3. NOT HAVE A FINANCIAL RELATIONSHIP WITH A DEFENSIVE DRIVING
16 SCHOOL THAT PROVIDES SERVICES IN THIS STATE.

17 4. NOT DIRECT, FAVOR, SUPPORT, ENDORSE OR OTHERWISE INDUCE AN
18 INDIVIDUAL TO ATTEND A SPECIFIC DEFENSIVE DRIVING SCHOOL.

19 Sec. 3. Legislative intent

20 The legislature intends:

21 1. That the administrative office of the courts allow an individual
22 to make court diversion fee payments prescribed in section 28-3396, Arizona
23 Revised Statutes, as amended by this act, and defensive driving school fund
24 fees and fees for a defensive driving school course prescribed in section

Senate Amendments to H.B. 2522

1 28-3397, Arizona Revised Statutes, as amended by this act, over time and
2 attend defensive driving school when all fees are paid.

3 2. That the fee payments described in paragraph 1 of this section be
4 accomplished free of charge or as close to free of charge as possible to
5 the individual in a manner that is similar to other payment plans that the
6 administrative office of the courts allows before the effective date of
7 this act."
