AMENDING SECTION 28-2432, ARIZONA REVISED STATUTES; RELATING TO ARIZONA PROFESSIONAL BASKETBALL CLUB SPECIAL PLATES.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Section 28-2432, Arizona Revised Statutes, is amended to
3 read:

4 28-2432. Arizona professional basketball clubs special
5 plates; fund

6 A. ~~If, by December 31, 2008, a charitable organization affiliated~~
7 ~~with an Arizona professional basketball club donates thirty-two thousand~~
8 ~~dollars to the veterans' donations fund established by section 41-608 for~~
9 ~~the purpose of paying the implementation costs of the gold star family~~
10 ~~special plates established by section 28-2431 and the thirty-two thousand~~
11 ~~dollars is paid to the department for the implementation of this section,~~
12 The department shall issue Arizona professional basketball ~~club~~ CLUBS
13 special plates IN TWO DIFFERENT DESIGNS AS FOLLOWS:

14 1. ON OR BEFORE DECEMBER 31, 2024, the entity that provides the
15 ~~thirty-two thousand dollars~~ \$32,000 for the implementation of the Arizona
16 professional basketball ~~club~~ CLUBS special plates shall design the Arizona
17 professional MEN'S basketball club special plates. The design and color
18 of the Arizona professional MEN'S basketball club special plates are
19 subject to the approval of the department.

20 2. IF, BY DECEMBER 31, 2024, A PERSON PROVIDES AN ADDITIONAL
21 \$32,000 TO THE DEPARTMENT FOR THE ARIZONA PROFESSIONAL BASKETBALL CLUBS
22 SPECIAL PLATES, THE PERSON THAT PROVIDES THE \$32,000 SHALL DESIGN THE
23 ARIZONA PROFESSIONAL WOMEN'S BASKETBALL CLUB SPECIAL PLATES. THE DESIGN
24 AND COLOR OF THE ARIZONA PROFESSIONAL WOMEN'S BASKETBALL CLUB SPECIAL
25 PLATES ARE SUBJECT TO THE APPROVAL OF THE DEPARTMENT.

26 B. ALL OF THE FOLLOWING APPLY TO THE ARIZONA PROFESSIONAL
27 BASKETBALL CLUBS SPECIAL PLATES ISSUED PURSUANT TO SUBSECTION A OF THIS
28 SECTION:

29 1. The director may allow a request for Arizona professional
30 basketball ~~club~~ CLUBS special plates to be combined with a request for
31 personalized special plates. If the director allows such a combination,
32 the request shall be in a form prescribed by the director and is subject
33 to the fees for the personalized special plates in addition to the fees
34 required for Arizona professional basketball ~~club~~ CLUBS special plates.

35 B. 2. Of the ~~twenty-five dollar~~ \$25 fee required by section
36 28-2402 for the original special plates and for renewal of special plates,
37 ~~eight dollars~~ \$8 is a special plate administration fee and ~~seventeen~~
38 ~~dollars~~ \$17 is an annual donation.

39 C. 3. The department shall deposit, pursuant to sections 35-146
40 and 35-147, all special plate administration fees in the state highway
41 fund established by section 28-6991 and all donations collected pursuant
42 to this section in the Arizona professional basketball ~~club~~ CLUBS special
43 plate fund established by subsection D C of this section.

1 **D.** C. The Arizona professional basketball ~~club~~ CLUBS special plate
2 fund is established consisting of monies received pursuant to this
3 section. The director shall administer the fund. The first ~~thirty-two~~
4 ~~thousand dollars~~ \$32,000 received PURSUANT TO SUBSECTION A, PARAGRAPH 1 OF
5 THIS SECTION shall be reimbursed to the entity that paid the
6 implementation fee to the department ~~pursuant to subsection A of this~~
7 ~~section AND THE FIRST \$32,000 RECEIVED PURSUANT TO SUBSECTION A, PARAGRAPH~~
8 ~~2 OF THIS SECTION SHALL BE REIMBURSED TO THE PERSON THAT PAID THE~~
9 ~~IMPLEMENTATION FEE TO THE DEPARTMENT.~~ Not more than ten ~~per cent~~ PERCENT
10 of monies deposited in the fund annually shall be used for the cost of
11 administering the fund. Monies in the fund are continuously
12 appropriated. The director shall allocate monies from the fund through a
13 private Arizona professional basketball organization's foundation that is
14 qualified under section 501(c)(3) of the United States internal revenue
15 code for federal income tax purposes. The director shall forward all
16 monies deposited in the Arizona professional basketball ~~club~~ CLUBS special
17 plate fund, excluding administrative fees, to the foundation on an annual
18 basis.

19 **E.** D. On notice from the director, the state treasurer shall
20 invest and divest monies in the fund as provided by section 35-313, and
21 monies earned from investment shall be credited to the fund.
