AN ACT

AMENDING TITLE 18, ARIZONA REVISED STATUTES, BY ADDING CHAPTER 7; RELATING TO INFORMATION TECHNOLOGY.

1 Be it enacted by the Legislature of the State of Arizona:
2 Section 1. Title 18, Arizona Revised Statutes, is amended by adding
3 chapter 7, to read:

5 ARTIFICIAL INTELLIGENCE

6 ARTICLE 1. GENERAL PROVISIONS

7 18-701. Artificial intelligence; prohibited use; enforcement;
8 civil penalty; definition

9 A. A PERSON OR ENTITY THAT ESTABLISHES, CREATES OR USES AN
10 ARTIFICIAL INTELLIGENCE SYSTEM MAY NOT ALLOW THE SYSTEM TO CREATE, STORE
11 OR USE CHILD SEXUAL ABUSE MATERIAL.

12 B. A KNOWING AND WILFUL VIOLATION OF THIS SECTION IS AN UNLAWFUL
13 PRACTICE PURSUANT TO SECTION 44-1522, AND ONLY THE ATTORNEY GENERAL MAY
14 ENFORCE THE VIOLATION BY INVESTIGATING AND TAKING APPROPRIATE ACTION
15 PURSUANT TO TITLE 44, CHAPTER 10, ARTICLE 7. THE ATTORNEY GENERAL MAY
16 IMPOSE A CIVIL PENALTY FOR A VIOLATION OF THIS SECTION NOT TO EXCEED THE
17 LESSER OF \$10,000 PER AFFECTED INDIVIDUAL OR THE TOTAL AMOUNT OF ECONOMIC
18 LOSS SUSTAINED BY AFFECTED INDIVIDUALS, BUT THE MAXIMUM CIVIL PENALTY FROM
19 A VIOLATION OF THIS SECTION OR SERIES OF RELATED VIOLATIONS MAY NOT EXCEED
20 \$500,000. THIS SECTION DOES NOT PREVENT THE ATTORNEY GENERAL FROM
21 RECOVERING RESTITUTION FOR AFFECTED INDIVIDUALS.

22 C. FOR THE PURPOSES OF THIS SECTION, "CHILD SEXUAL ABUSE MATERIAL"
23 MEANS A VISUAL DEPICTION OF SEXUAL EXPLOITATION OF A MINOR.
