# HOUSE BILL 2403

AN ACT

AMENDING SECTION 16-927, ARIZONA REVISED STATUTES; RELATING TO CAMPAIGN  
FINANCE.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 16-927, Arizona Revised Statutes, is amended to  
3 read:

4 16-927. Campaign finance reporting period

5 A. A political action committee and political party shall file a  
6 campaign finance report covering each reporting period as follows:

7 1. For a calendar quarter without an election, the political action  
8 committee or political party shall file a quarterly report. The quarterly  
9 report shall be:

10 (a) Filed not later than the third Monday in the month after the  
11 calendar quarter.

12 (b) Complete through the last day of the calendar quarter.

13 2. For a calendar quarter with an election, the political action  
14 committee or political party shall file a preelection and postelection  
15 report as follows:

16 (a) A preelection report shall be:

17 (i) Filed not later than ten days before the election.

18 (ii) Complete from the first day of the applicable calendar quarter  
19 through the seventeenth day before the election.

20 (b) A postelection report shall be:

21 (i) Filed not later than the fifteenth day after the applicable  
22 calendar quarter.

23 (ii) Complete from the sixteenth day before the election through  
24 the last day of the applicable calendar quarter.

25 B. A candidate committee, **OTHER THAN A STATEWIDE CANDIDATE**  
26 **COMMITTEE**, shall file a campaign finance report only during the four  
27 calendar quarters comprising the twelve-month period preceding the general  
28 election for the office for which the candidate is seeking election, or  
29 for cities and towns, the city's or town's second, runoff or general  
30 election, however designated by the city or town. **A CANDIDATE COMMITTEE**  
31 **FOR A STATEWIDE CANDIDATE SHALL FILE A CAMPAIGN FINANCE REPORT DURING**  
32 **EACH CALENDAR QUARTER COMPRISING THE FORTY-EIGHT-MONTH PERIOD PRECEDING**  
33 **THE GENERAL ELECTION FOR THE OFFICE FOR WHICH THE CANDIDATE IS SEEKING**  
34 **ELECTION.**

35 C. The reporting period for a candidate committee's first campaign  
36 finance report of the election cycle shall include the entire election  
37 cycle to date.
