### AN ACT

AMENDING TITLE 16, CHAPTER 4, ARTICLE 1, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 16-407.04; RELATING TO CONDUCT OF ELECTIONS.

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Title 16, chapter 4, article 1, Arizona Revised  
3 Statutes, is amended by adding section 16-407.04, to read:

4       16-407.04. Election security standards and practices  
5                   committee; membership; reviews; schedule

6       THE SECRETARY OF STATE, IN CONSULTATION AND COOPERATION WITH COUNTY  
7 RECORDERS, COUNTY ELECTION OFFICERS, CITY AND TOWN CLERKS AND ELECTION  
8 OFFICERS AND COUNTY BOARDS OF SUPERVISORS, SHALL ESTABLISH AN ELECTION  
9 SECURITY STANDARDS AND PRACTICES COMMITTEE CONSISTING OF REPRESENTATIVES  
10 FROM THOSE ELECTED OFFICIALS, ELECTION ADMINISTRATORS AND TECHNICAL  
11 EXPERTS. THE COMMITTEE SHALL:

12       1. CREATE AND DISSEMINATE REQUIRED AND RECOMMENDED ELECTION  
13 SECURITY CONTROLS TO BE IMPLEMENTED BY ELECTION JURISDICTIONS, INCLUDING  
14 CONTROLS FOR TESTING AND VERIFYING EQUIPMENT.

15       2. CREATE AND DISSEMINATE A SELF-ASSESSMENT QUESTIONNAIRE THAT THE  
16 JURISDICTIONS MUST USE TO CONFIRM COMPLIANCE WITH THE STANDARDS.

17       3. ESTABLISH A PROCESS AND SCHEDULE FOR REGULAR REVIEW OF AND  
18 UPDATES TO SECURITY STANDARDS, PRACTICES AND EQUIPMENT AND FOR COMPLIANCE  
19 REVIEW AS FOLLOWS:

20       (a) ON OR BEFORE JANUARY 1 OF EACH ODD-NUMBERED YEAR, IMPROVE AND  
21 UPDATE THE STANDARDS, AFTER OPPORTUNITY FOR PUBLIC COMMENT.

22       (b) ON OR BEFORE FEBRUARY 1 OF EACH ODD-NUMBERED YEAR, SUBMIT TO  
23 THE SECRETARY OF STATE FOR PUBLICATION AND DISSEMINATION A SELF-ASSESSMENT  
24 QUESTIONNAIRE THAT JURISDICTIONS MUST COMPLETE TO CONFIRM COMPLIANCE WITH  
25 THAT YEAR'S STANDARDS.

26       (c) ON OR BEFORE FEBRUARY 1 OF EACH EVEN-NUMBERED YEAR, REQUIRE  
27 EACH JURISDICTION TO SUBMIT ITS COMPLETED SELF-ASSESSMENT TO THE SECRETARY  
28 OF STATE.
