## A RESOLUTION

DECLARING GUN VIOLENCE A PUBLIC HEALTH CRISIS IN ARIZONA.

1       Whereas, the United States is in the midst of a troubling crime  
2 wave. 2019 to 2020 saw the single largest year-to-year increase in murders  
3 in our nation's history, a trend that continued into 2021. Nonfatal  
4 shootings and other aggravated assaults have also dramatically increased  
5 in many jurisdictions; and

6       Whereas, according to the latest statistics from the Centers for  
7 Disease Control and Prevention, more Americans died of gun-related  
8 injuries in 2021 than in any other year on record; and

9       Whereas, gun violence is a daily scourge that threatens our most  
10 fundamental right: the right to life. More than 600 people die every day  
11 as a result of firearms violence, which is driven in part by easy access  
12 to firearms; and

13      Whereas, gun ownership is consistently correlated with rates of  
14 firearm suicides, homicides and accidental shootings; and

15      Whereas, Americans are 25 times more likely to be killed in a gun  
16 homicide than residents of high-income peer countries; and

17      Whereas, the American Medical Association has formally recognized  
18 gun violence as a public health crisis; and

19      Whereas, firearms cause devastating injuries that result in lasting  
20 consequences on physical and mental health for individuals, families and  
21 communities. Some gunshot victims need intensive, lifelong care. Others  
22 may lose their ability to work. Many have little or no access to programs  
23 that offer adequate long-term care and rehabilitation; and

24      Whereas, the impact of gun violence extends beyond physical injuries  
25 and fatalities, including emotional trauma, economic burdens and  
26 long-lasting suffering for affected individuals and their families; and

27      Whereas, beginning in 2014, firearm death rates began significantly  
28 increasing in Arizona; and

29      Whereas, gun violence is one of the leading causes of death in both  
30 adults and children in this state; and

31      Whereas, in 2020 alone, 1,265 Arizonans were killed due to firearms;  
32 and

33      Whereas, in 2022, according to Arizona's child fatality review,  
34 firearm deaths surpassed drug overdoses and car accidents as the number  
35 one cause of death of children 15 to 17 years of age; and

36      Whereas, our human rights are not protected if our leaders fail to  
37 tackle and end the epidemic of gun violence and gun deaths.

38 Therefore

39 Be it resolved by the House of Representatives of the State of Arizona:

40      That the Members of the House of Representatives declare gun  
41 violence a public health crisis in this state.
