AN ACT

APPROPRIATING MONIES FOR THE RELIEF OF NAMED CLAIMANTS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Supplemental appropriations for relief of named  
 3 claimants; basis of claims; coordination

4 A. The payment of the sums appropriated by this section is in full  
 5 satisfaction of the claims described in this section. The department of  
 6 administration shall coordinate payments.
