AN ACT

ESTABLISHING THE STUDY COMMITTEE ON REGISTERED SEX OFFENDERS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Study committee on registered sex offenders;
3 membership; duties; delayed repeal

4 A. The study committee on registered sex offenders is established
5 consisting of the following members:

6 1. Three members of the senate, not more than two of whom are
7 members of the same political party and who are appointed as follows:

8 (a) One member who is appointed by the president of the senate and
9 who is designated by the president of the senate to serve as
10 cochairperson.

11 (b) One member who is appointed by the majority leader of the
12 senate.

13 (c) One member who is appointed by the minority leader of the
14 senate.

15 2. Three members of the house of representatives, not more than two
16 of whom are members of the same political party and who are appointed as
17 follows:

18 (a) One member who is appointed by the speaker of the house of
19 representatives and who is designated by the speaker of the house of
20 representatives to serve as cochairperson.

21 (b) One member who is appointed by the majority leader of the house
22 of representatives.

23 (c) One member who is appointed by the minority leader of the house
24 of representatives.

25 B. A majority of the members of the committee constitutes a quorum.
26 The committee shall do all of the following:

27 1. Meet as often as the cochairpersons deem necessary and in any
28 place that the cochairpersons deem necessary or convenient.

29 2. Study current policies and practices of local, state and tribal
30 law enforcement agencies and county attorneys that relate to sexual
31 offenses.

32 3. Examine the effectiveness of the current sex offender laws in
33 this state to prevent recidivism and protect the community from further
34 sexual offenses.

35 4. Examine the standards set forth by the Adam Walsh Child
36 Protection and Safety Act of 2006 (P.L. 109-248) and Title 1 of the Sex
37 Offender Registration and Notification Act (P.L. 109-248).

38 C. On request of the committee, an agency of this state or a
39 political subdivision of this state shall provide the committee with its
40 services, equipment, documents, personnel and facilities to the extent
41 possible without cost to the committee.

1 D. The committee may use the services of legislative staff to
2 provide necessary administrative and operational services.

3 E. On or before December 31, 2024, the committee may submit a
4 report of its findings and recommendations to the governor, the president
5 of the senate and the speaker of the house of representatives and shall
6 provide a copy of this report to the secretary of state and the director
7 of the secretary of state.

8 F. This section is repealed from and after September 30, 2025.
