**CHAPTER 49**  
**SENATE BILL 1110**

AN ACT

AMENDING SECTION 41-1365, ARIZONA REVISED STATUTES; RELATING TO THE STATE MONUMENT AND MEMORIAL REPAIR FUND.

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 41-1365, Arizona Revised Statutes, is amended to  
3 read:  
4           41-1365. State monument and memorial repair fund; purpose;  
5                   annual report; exemption  
6       A. The state monument and memorial repair fund is established  
7 consisting of:  
8           1. Donations.  
9           2. Monies from fundraising activities.  
10          3. Monies that are collected by the proponents of a monument or  
11 memorial and that are deposited pursuant to section 41-1363.  
12          4. Grants received for monuments or memorials, except for otherwise  
13 specifically dedicated grants.  
14          5. Legislative appropriations.  
15       B. The legislative council shall administer the fund. All monies  
16 in the fund are ~~subject to legislative appropriation CONTINUOUSLY~~  
17 APPROPRIATED. Subject to this section, the ~~department~~ LEGISLATIVE COUNCIL  
18 shall use monies ~~appropriated from~~ IN the fund to:  
19          1. Maintain, repair, recondition or relocate monuments or  
20 memorials.  
21          2. Support mechanical equipment in the governmental mall.  
22       C. The legislative council shall separately account for monies to a  
23 specific monument or memorial that is dedicated to this state for  
24 maintaining, repairing, reconditioning or relocating that monument or  
25 memorial as follows:  
26          1. Monies that are donated for the benefit of the specific monument  
27 or memorial.  
28          2. Monies that are derived from fundraising activities and that are  
29 collected for the benefit of a specific monument or memorial.  
30          3. Monies that are collected and deposited pursuant to subsection  
31 A, paragraph 3 of this section.  
32       D. On or before November 1 of each year, the legislative council  
33 shall submit to the joint legislative budget committee a report that  
34 accounts for all monies deposited in the fund. The report shall include  
35 the sources of the monies received for deposit, by category, and the  
36 purposes for which the monies were used during the preceding fiscal year.  
37       E. The legislative council shall hold the monies in the fund in  
38 trust for the citizens of this state until spent on an authorized monument  
39 or memorial, and monies in the fund shall not be spent or appropriated for  
40 any other purpose.  
41       F. Monies in the fund are exempt from the provisions of section  
42 35-190 relating to lapsing of appropriations.
