**CHAPTER 135**  
**HOUSE BILL 2178**

AN ACT

AMENDING SECTION 15-1626.01, ARIZONA REVISED STATUTES; RELATING TO THE ARIZONA BOARD OF REGENTS.

1 Be it enacted by the Legislature of the State of Arizona:  
2       Section 1. Section 15-1626.01, Arizona Revised Statutes, is amended  
3 to read:

4       15-1626.01. Tuition and fees; student organizations;  
5       prohibition; support; selection by students

6       A. A university under the jurisdiction of the Arizona board of  
7 regents shall not transfer any portion of the tuition or fees collected  
8 from students pursuant to section 15-1626 or use any university student  
9 billing process to collect monies on behalf of an organization **THAT IS** not  
10 under the jurisdiction of the Arizona board of regents and **THAT IS** not  
11 recognized as a university student organization.

12       B. A university under the jurisdiction of the Arizona board of  
13 regents may establish and support student government at the university and  
14 the ~~university recognized~~ UNIVERSITY-RECOGNIZED student organizations and  
15 clubs,~~—~~ and **MAY** provide support for these student groups from tuition and  
16 fees pursuant to section 15-1633.

17       C. EACH UNIVERSITY UNDER THE JURISDICTION OF THE ARIZONA BOARD OF  
18 REGENTS THAT ALLOCATES STUDENT FEE MONIES TO SUPPORT THE ACTIVITIES OF  
19 INDIVIDUAL UNIVERSITY-RECOGNIZED STUDENT ORGANIZATIONS OR CLUBS SHALL:

20           1. PROVIDE EACH STUDENT WHO IS CHARGED FEES WITH A REASONABLE  
21 OPPORTUNITY TO SELECT ONE OR MORE STUDENT ORGANIZATIONS OR CLUBS, OR BOTH,  
22 TO WHICH THE UNIVERSITY MAY NOT ALLOCATE THE STUDENT'S PRO RATA SHARE OF  
23 THE FEE MONIES.

24           2. FOR EACH STUDENT WHO MAKES A SELECTION PURSUANT TO PARAGRAPH 1  
25 OF THIS SUBSECTION, USE THE STUDENT'S PRO RATA SHARE OF THE FEE MONIES  
26 THAT THE UNIVERSITY ALLOCATES PURSUANT TO THIS SUBSECTION ONLY FOR  
27 PROGRAMS THAT ARE OPEN TO ALL STUDENTS.

28           3. IF A STUDENT DOES NOT SELECT ONE OR MORE STUDENT ORGANIZATIONS  
29 OR CLUBS PURSUANT TO PARAGRAPH 1 OF THIS SUBSECTION, THE UNIVERSITY MAY  
30 ALLOCATE THE STUDENT'S PRO RATA SHARE OF THE FEE MONIES TO EITHER SUPPORT  
31 THE ACTIVITIES OF ANY INDIVIDUAL UNIVERSITY-RECOGNIZED STUDENT  
32 ORGANIZATION OR CLUB OR TO PROGRAMS THAT ARE OPEN TO ALL STUDENTS.
