HOUSE OF REPRESENTATIVES AMENDMENTS TO S.B. 1168

(Reference to Senate engrossed bill)

1 Strike everything after the enacting clause and insert:

2 "Section 1. Section 28-4802, Arizona Revised Statutes, is amended to
3 read:

4 28-4802. Fees

5 A. Except as provided in subsection B of this section, the owner of
6 record of a vehicle at the time of abandonment of the vehicle is liable to
7 the department for the transfer of ownership or disposal in an amount
8 ~~prescribed by the director by rule~~ NOT TO EXCEED \$400 if the vehicle was:

9 1. Abandoned and junked pursuant to article 3 of this chapter on
10 private property or public land or on or within the right-of-way of a
11 street or highway.

12 2. Abandoned on private property or public land or on or within the
13 right-of-way of a street or highway and the department issues a transfer of
14 ownership pursuant to the procedures prescribed by this chapter.

15 3. Abandoned and junked pursuant to article 3 of this chapter and
16 towed with the written permission of the state land commissioner from state
17 trust land located within the boundaries of an incorporated city or town.

18 B. The owner of record of a vehicle at the time of abandonment is
19 liable to the department for the transfer of ownership or disposal in an
20 amount prescribed by the director by rule if the vehicle was:

21 1. Abandoned and junked pursuant to article 3 of this chapter and
22 towed with the written permission of the governing authority off of

1 national forest, state park, bureau of land management or state trust land
2 located outside the boundaries of an incorporated city or town.

3 2. Abandoned and towed with the written permission of the governing
4 authority off of national forest, state park, bureau of land management or
5 state trust land located outside the boundaries of an incorporated city or
6 town and the department issues a transfer of ownership pursuant to the
7 procedures prescribed by this chapter.

8 3. Abandoned outside the right-of-way of a street or highway located
9 outside the boundaries of an incorporated city or town.

10 C. In addition to the registration fee or driver license fee
11 prescribed by sections 28-2003 and 28-3002, the department shall collect
12 the fee prescribed in subsections A and B of this section as an additional
13 registration fee at the time the owner of the vehicle subsequently
14 registers another vehicle in this state or as an additional driver license
15 fee at the time the owner of the vehicle subsequently applies for or renews
16 a driver license issued by this state. The department shall deposit,
17 pursuant to sections 35-146 and 35-147, the additional fee collected for
18 the transfer of ownership or disposal in the abandoned vehicle
19 administration fund established by section 28-4804, except that ninety ~~per~~
20 ~~cent~~ PERCENT of the fees collected pursuant to subsection A of this section
21 and sixty ~~per cent~~ PERCENT of the fees collected pursuant to subsection B
22 of this section shall be deposited in the state highway fund.

23 D. The department:

24 1. Shall notify the owner of an abandoned vehicle for which
25 ownership has been transferred or of a junk vehicle that has been disposed
26 of about the additional fee at the time of a subsequent vehicle
27 registration or driver license application or renewal.

28 2. Shall provide a complete description of the abandoned or junked
29 vehicle, the vehicle identification number of the vehicle and the date on
30 which the vehicle was disposed of or ownership was transferred by the
31 department.

1 A. Before the distribution of abandoned vehicle fees collected
2 pursuant to section 28-4802, subsection C and before the distribution of
3 vehicle license tax monies pursuant to section 28-5808, subsection D, the
4 department shall deposit ~~twenty~~ TWENTY-FIVE percent of abandoned vehicle
5 fees collected in the abandoned vehicle administration fund established by
6 section 28-4804.

7 B. The director, in consultation with registered towing companies in
8 this state, shall establish a monthly payment system to reimburse
9 registered towing companies that are entitled to partial reimbursement
10 under section 28-4805."
