1 Page 1, line 27, after ""PEDIATRICIAN"," insert ""PLASTIC SURGEON", "FAMILY  
2 PHYSICIAN", "FAMILY MEDICINE PHYSICIAN",

3 Page 2, line 6, after "TITLE" insert "IN AN ADVERTISEMENT, PROFESSIONAL  
4 COMMUNICATION OR CLINICAL SETTING"

5 Line 23, after "NOT" insert "PROHIBIT A HEALTH PROFESSIONAL FROM DOING ANY OF  
6 THE FOLLOWING"

7 Line 24, strike "PROHIBIT A HEALTH PROFESSIONAL FROM"

8 Line 26, strike "PROHIBIT ANY HEALTH PROFESSIONAL FROM"; after "DISPLAYING"  
9 insert "IN ANY CLINICAL SETTING ANY"

10 Line 27, strike "IN ANY CLINICAL SETTING"

11 Line 28, strike "PREVENT A HEALTH PROFESSIONAL FROM"

12 Between lines 30 and 31, insert:

13 "4. USING A TITLE IN A NONCLINICAL SETTING OR IN COMMUNICATIONS THAT  
14 ARE NOT DIRECTED TO PATIENTS OR PROSPECTIVE PATIENTS.

15 5. USING A TITLE IN A CLINICAL SETTING IF THE HEALTH PROFESSIONAL,  
16 WHO IS NOT A PHYSICIAN, IS AN INSTRUCTOR WHO POSSESSES A DOCTORAL-LEVEL  
17 DEGREE AND WHO IS PROVIDING DIRECT INSTRUCTION TO STUDENTS."

18 Line 40, after "CARDS" insert "THAT ARE PROVIDED TO PATIENTS OR PROSPECTIVE  
19 PATIENTS"; after "BADGES" insert "THAT ARE USED IN A CLINICAL SETTING"

20 After line 43, insert:

21 "2. "CLINICAL SETTING" MEANS A SETTING IN WHICH THE PRIMARY PURPOSE  
22 IS TO DELIVER MEDICAL CARE OR HEALTH CARE SERVICES TO PATIENTS."

23 Renumber to conform

1 Page 3, between lines 7 and 8, insert:

2                   "4. "PROFESSIONAL COMMUNICATION" MEANS ANY COMMUNICATION BETWEEN A  
3           LICENSED HEALTH PROFESSIONAL AND A PATIENT OR PROSPECTIVE PATIENT REGARDING  
4           MEDICAL CARE OR HEALTH CARE SERVICES."
