HOUSE OF REPRESENTATIVES AMENDMENTS TO H.B. 2252

1 Page 3, between lines 39 and 40, insert:

2 "Sec. 5. Section 23-575, Arizona Revised Statutes, is amended to
3 read:

4 23-575. Violations; classification; civil penalties; rules

5 ~~A. A person who offers to provide or actually provides professional~~
6 ~~employer services or uses the name professional employer organization,~~
7 ~~staff leasing, employee leasing or administrative employee or any other~~
8 ~~title representing a professional employer service without first~~
9 ~~registering with the secretary of state pursuant to section 23-563 is~~
10 ~~guilty of a class 1 misdemeanor.~~

11 ~~B. A person who knowingly provides false or fraudulent information~~
12 ~~to the secretary of state under this article is guilty of a class 1~~
13 ~~misdemeanor.~~

14 ~~C.~~ A. A person who is a controlling person of a professional
15 employer organization and who collects payments from a client representing
16 wages, taxes, benefit payments or insurance payments and fails to remit the
17 funds to the appropriate government or private entity within a reasonable
18 time is guilty of theft as provided in section 13-1802.

19 ~~D.~~ B. A person who is a controlling person of a client of a
20 professional employer organization and who fraudulently or falsely procures
21 or attempts to procure services or benefits from a ~~registered~~ professional
22 employer organization without having monies that are adequate to compensate
23 the professional employer organization is guilty of a class 4 felony.

1 ~~E.~~ C. If a person wilfully fails to comply with any requirement of
2 this article, knowingly makes a material misrepresentation to the secretary
3 of state, violates subsection A, ~~B or C~~ of this section or is guilty of an
4 offense relating to the operation of a professional employer organization,
5 the secretary of state:

6 ~~I.~~ Shall impose a civil penalty not to exceed one thousand dollars
7 against the person for each violation. The secretary of state shall
8 deposit, pursuant to sections 35-146 and 35-147, penalties collected
9 pursuant to this paragraph in the state general fund.

10 ~~2. May deny an application for registration.~~

11 ~~3. May revoke, restrict or refuse to renew a registration.~~

12 ~~4. May place a registrant on probation for a period of time~~
13 ~~determined by rules adopted by the secretary of state.~~

14 ~~F.~~ D. The secretary of state shall adopt rules for hearings and
15 penalties for violations of this article or rules adopted under this
16 article."
