3 48, CHAPTER 31"

4 Page 4, line 14, after the second quotation mark insert ":

5 (a)"; strike "AN" insert "A GROUND"

6 Between lines 15 and 16, insert:

7 "(b) DOES NOT INCLUDE AN AIR AMBULANCE TRANSPORT."

8 Page 6, between lines 2 and 3, insert:

10 Statutes, is amended by adding section 36-2248, to read:

11 36-2248. Interfacility transport; determination; insurance

13 THE DETERMINATION BY A CERTIFICATE OF NECESSITY OR CERTIFICATE OF  
14 OPERATION HOLDER OF WHETHER TO PROVIDE AN INTERFACILITY TRANSPORT FOR A  
15 PATIENT MAY NOT BE MADE BASED ON THE PATIENT'S INSURANCE STATUS."

21 AN ELIGIBLE ENTITY THAT HOLDS A CERTIFICATE OF OPERATION AND THAT IS  
22 TRANSFERRING A PATIENT TO ANOTHER HEALTH CARE INSTITUTION THAT DOES NOT  
23 HAVE THE SAME DIRECT OWNER OR INDIRECT OWNER SHALL FIRST CALL THE  
24 CERTIFICATE OF NECESSITY HOLDER BEFORE TRANSPORTING THE PATIENT. IF THE

1 CERTIFICATE OF NECESSITY HOLDER IS UNABLE TO PROVIDE THE INTERFACILITY  
2 TRANSPORT EITHER WITHIN THE TIME FRAME IN WHICH THE AMBULANCE IS NEEDED AS  
3 DETERMINED BY THE PATIENT'S TREATING MEDICAL PROVIDER OR WITH THE MEDICAL  
4 EQUIPMENT AND TRAINED PERSONNEL NECESSARY TO TRANSFER THE PATIENT SAFELY AS  
5 DETERMINED BY THE PATIENT'S TREATING MEDICAL PROVIDER, THE CERTIFICATE OF  
6 OPERATION HOLDER MAY TRANSPORT THE PATIENT TO THE OTHER HEALTH CARE  
7 INSTITUTION. THE TRANSFERRING HEALTH CARE INSTITUTION SHALL DOCUMENT THE  
8 REQUIRED CALL TO THE CERTIFICATE OF NECESSITY HOLDER UNDER THIS SECTION."
