SENATE AMENDMENTS TO S.B. 1064

(Reference to printed bill)

1 Page 4, between lines 39 and 40, insert:

2 "5. A GASOLINE THAT MEETS STANDARDS FOR FEDERAL CONVENTIONAL  
3 GASOLINE. THE GASOLINE SHALL ALSO MEET THE MAXIMUM VAPOR PRESSURE  
4 REQUIREMENTS IN SECTION 3-3433, SUBSECTION F. FOR THE PERIOD BEGINNING  
5 NOVEMBER 1 THROUGH MARCH 31 OF EACH YEAR, THE GASOLINE SHALL ALSO MEET THE  
6 MINIMUM OXYGEN CONTENT OR PERCENTAGE REQUIREMENTS PRESCRIBED IN SECTION  
7 3-3492."

24 NOVEMBER 1 THROUGH MARCH 31 OF EACH YEAR, THE GASOLINE SHALL ALSO MEET THE

14 "5. A GASOLINE THAT MEETS STANDARDS FOR CALIFORNIA PHASE 2  
15 REFORMULATED GASOLINE, INCLUDING ALTERNATIVE FORMULATIONS ALLOWED BY THE  
16 PREDICTIVE MODEL, AS ADOPTED BY THE CALIFORNIA AIR RESOURCES BOARD PURSUANT  
17 TO CALIFORNIA CODE OF REGULATIONS TITLE 13, SECTIONS 2261 THROUGH 2262.7  
18 AND 2265, IN EFFECT ON JANUARY 1, 1997, EXCEPT THAT THE MINIMUM OXYGEN  
19 CONTENT STANDARD DOES NOT APPLY. THE GASOLINE SHALL ALSO MEET THE MAXIMUM  
20 VAPOR PRESSURE REQUIREMENTS IN SECTION 3-3434, SUBSECTION D.

21 6. A GASOLINE THAT MEETS STANDARDS FOR FEDERAL CONVENTIONAL  
22 GASOLINE. THE GASOLINE SHALL ALSO MEET THE MAXIMUM VAPOR PRESSURE  
23 REQUIREMENTS IN SECTION 3-3433, SUBSECTION F AND THE MINIMUM OXYGEN CONTENT  
24 OR PERCENTAGE REQUIREMENTS PRESCRIBED IN SECTION 3-3492."

12 Line 18, strike "thirty" insert "one hundred twenty"

13 Between lines 37 and 38, insert:

14           "C. The weights and measures services division of the Arizona  
15           department of agriculture and the division's associate director shall  
16           maintain a list of all approved gasoline formulations by area in this state  
17           on the department's website. The associate director shall update the list  
18           as the United States environmental protection agency approves or denies new  
19           gasoline formulations pursuant to this act. The associate director shall  
20           post separately on the department's website both of the following:

21           1. A map that includes all currently approved gasoline formulations  
22           by area in this state.

23           2. A map of area A, area B and area C as defined in section 49-541,  
24           Arizona Revised Statutes."
