1 Page 3, line 14, after "A" insert "WRITTEN"; after the first "THE" insert  
2 "SUPERVISING"; after the second "TO" insert "COURTESY"  
3 Line 16, strike "JURISDICTION" insert "COUNTY"; after "STATE" insert "WITH THE  
4 INTENT TO RESIDE IN THAT COUNTY"  
5 Line 17, after the second "HOUSING" insert "THAT WILL ASSIST IN THE  
6 PROBATIONER'S POSITIVE BEHAVIORAL CHANGE"  
7 Strike lines 18 through 22, insert "THE SUPERVISING PROBATION DEPARTMENT SHALL  
8 DO ALL OF THE FOLLOWING:  
9       1. CONFIRM THE DETAILS OF THE PROBATIONER'S EMPLOYMENT, HOUSING OR

16 PROBATION DEPARTMENT PURSUANT TO SUBSECTION L OF THIS SECTION, THE  
17 RECEIVING PROBATION DEPARTMENT SHALL PROVIDE THE SENDING PROBATION  
18 DEPARTMENT WITH PERMISSION FOR THE PROBATIONER TO PROCEED TO THE RECEIVING  
19 COUNTY WITHIN SEVEN BUSINESS DAYS AFTER RECEIPT UNLESS THE RECEIVING  
20 PROBATION DEPARTMENT FINDS THE BASIS FOR THE PLAN IS NOT FACTUAL OR THE  
21 TRANSFER WILL ENDANGER THE VICTIM."
