SENATE AMENDMENTS TO H.B. 2186

(Reference to House engrossed bill)

5 2. "APPROVED BRACKISH GROUNDWATER PLAN" MEANS A PLAN THAT THE
6 DIRECTOR HAS APPROVED AND DETERMINED TO BE CONSISTENT WITH THE MANAGEMENT
7 GOALS OF AN ACTIVE MANAGEMENT AREA FOR THE WITHDRAWAL OF BRACKISH
8 GROUNDWATER WITHIN AN ACTIVE MANAGEMENT AREA."

10 "5. "BRACKISH GROUNDWATER" MEANS GROUNDWATER THAT CONTAINS TOTAL
11 DISSOLVED SOLIDS BETWEEN ONE THOUSAND AND TEN THOUSAND MILLIGRAMS PER
12 LITER."

11 5. IF THE BRACKISH GROUNDWATER WILL BE WITHDRAWN FROM AN EXEMPTION
12 AREA AS PRESCRIBED BY SECTION 45-411.01 OR THAT IS LOCATED WITHIN THE
13 BOUNDARIES OF AN IRRIGATION DISTRICT ESTABLISHED PURSUANT TO TITLE 48,
14 CHAPTER 19, THE PERSON USES OR OTHERWISE RETURNS THE TREATED BRACKISH
15 GROUNDWATER TO THE SAME EXEMPTION AREA OR SERVICE AREA OF AN IRRIGATION
16 DISTRICT FROM WHICH THE BRACKISH GROUNDWATER WAS ORIGINALLY WITHDRAWN."
