- 3 Line 16, strike "both" insert "ANY COMBINATION OF SCHOOL PSYCHOLOGISTS, SCHOOL
- 4 COUNSELORS OR SCHOOL SOCIAL WORKERS"
- 5 Line 19, strike "and" insert a comma; after "counseling" insert "AND
- 6 INTERVENTION"
- 7 Line 21, after the second "the" insert "SCHOOL PSYCHOLOGIST,"

- 20 SCHOOL SOCIAL WORKERS TO PARTNER WITH AND COMMUNICATE WITH THE PARENTS OF
