

PROPOSED

SENATE AMENDMENTS TO H.C.R. 2049

(Reference to House engrossed resolution)

1 Strike everything after the resolving clause and insert:

2 "1. Article IX, Constitution of Arizona, is proposed to be amended  
3 by adding section 26 as follows if approved by the voters and on  
4 proclamation of the Governor:

5 26. Vehicle miles traveled; taxing, monitoring and  
6 limiting prohibited; exceptions

7 SECTION 26. A. THIS STATE AND ANY COUNTY, CITY, TOWN,  
8 MUNICIPAL CORPORATION OR OTHER POLITICAL SUBDIVISION OF THIS  
9 STATE SHALL NOT DO EITHER OF THE FOLLOWING:

10 1. IMPOSE A TAX OR FEE ON ANY PERSON BASED ON THE  
11 VEHICLE MILES TRAVELED BY THE PERSON IN A MOTOR VEHICLE.

12 2. ENACT ANY RULE OR LAW TO MONITOR OR LIMIT THE VEHICLE  
13 MILES TRAVELED BY A PERSON IN A MOTOR VEHICLE UNLESS THE RULE  
14 OR LAW REQUIRES THAT THE PERSON VOLUNTARILY CONSENTS TO THE  
15 MONITORING OR LIMITATION.

16 B. THIS SECTION DOES NOT PREVENT:

17 1. THE EXECUTION OF AN INTERSTATE AGREEMENT THAT IS  
18 ESTABLISHED TO ADMINISTER THE PAYMENT OR REPORTING OF FUEL  
19 TAXES OR REGISTRATION FEES FOR COMMERCIAL VEHICLES THAT OPERATE  
20 IN MORE THAN ONE STATE.

21 2. A GOVERNMENTAL ENTITY FROM LIMITING OR MONITORING THE  
22 MILES TRAVELED BY A MOTOR VEHICLE THAT IS OWNED BY THE  
23 GOVERNMENTAL ENTITY.

1                   3. A GOVERNMENTAL ENTITY FROM PROVIDING REIMBURSEMENT  
2                   FOR AN EMPLOYEE'S TRAVEL EXPENSES.

3                   2. The Secretary of State shall submit this proposition to the  
4                   voters at the next general election as provided by article XXI,  
5                   Constitution of Arizona."
