## CHAPTER 39

# SENATE BILL 1231

AN ACT

AMENDING SECTION 22-131, ARIZONA REVISED STATUTES; RELATING TO CONSTABLE  
TRAINING.

(TEXT OF BILL BEGINS ON NEXT PAGE)

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Section 22-131, Arizona Revised Statutes, is amended to  
3 read:

4 22-131. Constables; powers and duties; prohibited acts

5 A. Constables shall attend the courts of justices of the peace  
6 within their precincts when required, and within their counties shall  
7 execute, serve and return all processes, warrants and notices directed or  
8 delivered to them by a justice of the peace of the county or by competent  
9 authority. In addition to any other provision of law these duties may be  
10 enforced by the presiding judge of the superior court in the county,  
11 including the use of the power of contempt.

12 B. Constables shall attend the training prescribed in section  
13 22-137.

14 C. Constables, with the consent of and at salaries fixed by the  
15 board of supervisors, may appoint deputies who are certified pursuant to  
16 section 41-1822, subsection A, paragraph 3, stenographers, clerks and  
17 assistants necessary to conduct the affairs of their offices. The  
18 appointments shall be in writing.

19 D. The provisions of law relating to sheriffs, as far as  
20 applicable, ~~shall~~ govern the powers, duties and liabilities of constables.

21 E. A constable who is duly elected or who is appointed by the board  
22 of supervisors has the authority of a peace officer only in the  
23 performance of the constable's official duties.

24 F. A constable may execute, serve and return processes and notices  
25 as prescribed in subsection A of this section within any precinct in  
26 another county if that precinct adjoins the precinct in which the  
27 constable was elected or appointed.

28 G. A constable is prohibited from engaging in any act as a private  
29 process server outside of the constable's elected or appointed duties. A  
30 constable shall not own an interest in any entity that operates a private  
31 process serving business.

32 H. AN ELECTED OR APPOINTED CONSTABLE MAY REQUEST TRAINING FROM THE  
33 CONSTABLE ETHICS STANDARDS AND TRAINING BOARD. IF APPROVED BY THE BOARD,  
34 THE TRAINING SHALL BE PAID FOR WITH BOARD MONIES AND PROVIDED BY A  
35 CONSTABLE WHO IS SELECTED BY THE BOARD AND WHO HAS COMPLETED THE MANDATORY  
36 BASIC TRAINING COURSE PRESCRIBED IN SECTION 22-137. THE CONSTABLE WHO IS  
37 SELECTED TO PROVIDE THE TRAINING MAY PROVIDE THAT TRAINING IN ANY COUNTY  
38 OF THIS STATE.
