3 Laws 2021, chapter 61, section 12, is amended to read:

5 The controlled substances listed or to be listed in the schedules in
6 sections 36-2512, 36-2513, 36-2514, 36-2515, 36-2516, ~~and~~ 36-2517 ~~AND~~
7 36-2517.02 or the rules adopted pursuant to this article are included by
8 whatever official, common, usual, chemical or trade name designated.

9 Sec. 2. Section 36-2511, Arizona Revised Statutes, as amended by
10 Laws 2023, chapter 97, section 1, is amended to read:

11 36-2511. Nomenclature

12 The controlled substances listed or to be listed in the schedules in
13 sections 36-2512, 36-2513, 36-2514, 36-2515, 36-2516, 36-2517, ~~and~~
14 36-2517.01 ~~AND~~ 36-2517.02 or the rules adopted pursuant to this article are
15 included by whatever official, common, usual, chemical or trade name
16 designated.

17 Sec. 3. Title 36, chapter 27, article 2, Arizona Revised Statutes,
18 is amended by adding section 36-2517.02, to read:

19 36-2517.02. United States food and drug administration;
20 approved medication; rescheduling

21 ANY PHARMACEUTICAL COMPOSITION OF CRYSTALLINE POLYMORPH PSILOCYBIN
22 THAT IS APPROVED BY THE UNITED STATES FOOD AND DRUG ADMINISTRATION AND
23 RESCHEDULED BY THE UNITED STATES DRUG ENFORCEMENT ADMINISTRATION TO A
24 SCHEDULE OTHER THAN SCHEDULE I OF THE CONTROLLED SUBSTANCES ACT
25 (P.L. 91-513; 84 STAT. 1242; 21 UNITED STATES CODE SECTIONS 801 THROUGH
26 904) IS A CONTROLLED SUBSTANCE FOR THE PURPOSES OF THIS CHAPTER AND MAY BE
27 PRESCRIBED IN THIS STATE.

28 Sec. 4. Legislative intent

29 If crystalline polymorph psilocybin is approved by the United States
30 food and drug administration and rescheduled by the United States drug

1 enforcement administration, it is this legislature's intent that patients
2 have rapid access to this treatment option.

3 Sec. 5. Conditional enactments; notice

4 A. Section 36-2511, Arizona Revised Statutes, as amended by Laws
5 2021, chapter 61, section 12 and this act, section 36-2517.02, Arizona
6 Revised Statutes, as added by this act, and section 4 of this act do not
7 become effective unless on or before January 1, 2031 crystalline polymorph
8 psilocybin is newly approved as a prescription medication pursuant to 21
9 United States Code section 355 and is controlled under a federal interim
10 final rule issued pursuant to 21 United States Code section 811(j) and
11 published in the Federal Register.

12 B. Section 36-2511, Arizona Revised Statutes, as amended by Laws
13 2023, chapter 97, section 1 and this act does not become effective unless
14 both the condition prescribed by Laws 2023, chapter 97, section 4 is met
15 and on or before January 1, 2031 crystalline polymorph psilocybin is newly
16 approved as a prescription medication pursuant to 21 United States Code
17 section 355 and is controlled under a federal interim final rule issued
18 pursuant to 21 United States Code section 811(j) and published in the
19 Federal Register.

20 C. The executive director of the Arizona state board of pharmacy
21 shall notify in writing the director of the Arizona legislative council on
22 or before February 1, 2031 either:

23 1. Of the date on which the condition was met.

24 2. That the condition was not met."
