## COMMITTEE ON GOVERNMENT SENATE AMENDMENTS TO H.C.R. 2037 (Reference to House engrossed resolution)

1 Strike everything after the resolving clause and insert:

"1. Article IV, part 2, section 2, Constitution of Arizona, is proposed to be amended as follows if approved by the voters and on proclamation of the Governor:

## 2. Qualifications of members of legislature

Section 2. No person shall be a member of the Legislature unless he shall be THE PERSON IS a citizen of the United States at the time of his election, nor unless he shall be IS at least twenty-five years of age, and shall have HAS been a resident of Arizona at least three years and of the county from which he is elected at least one year before his election AND HAS NOT BEEN A LOBBYIST FOR COMPENSATION WHO IS REQUIRED TO REGISTER WITH A FEDERAL AGENCY, THIS STATE OR A POLITICAL SUBDIVISION OF THIS STATE FOR ONE YEAR IMMEDIATELY PRECEDING THE PRIMARY ELECTION FOR THE LEGISLATURE.

2. Article V, section 2, Constitution of Arizona, is proposed to be amended as follows if approved by the voters and on proclamation of the Governor:

## 2. Eligibility to state offices

Section 2. No person shall be eligible to any of the offices mentioned in section 1 of this article except a person of the age of WHO IS not less than twenty-five years OF AGE, who shall have HAS been for ten years next preceding his election a citizen of the United States, and for five years next preceding his election a citizen of Arizona AND WHO HAS NOT BEEN A LOBBYIST FOR COMPENSATION WHO IS REQUIRED TO REGISTER WITH A FEDERAL AGENCY, THIS STATE OR A POLITICAL SUBDIVISION OF THE STATE FOR TWO YEARS IMMEDIATELY PRECEDING THE PRIMARY ELECTION FOR STATE OFFICE.

- 3. Article XI, section 2, Constitution of Arizona, is proposed to be amended as follows if approved by the voters and on proclamation of the Governor:
  - 2. Conduct and supervision of school system; lobbying
- Section 2. A. The general conduct and supervision of the public school system shall be vested in a state board of education, a state superintendent of public instruction, county school superintendents, and such governing boards for the state institutions as may be provided by law.
- B. A MEMBER OF A SCHOOL DISTRICT GOVERNING BOARD MAY NOT ENGAGE IN PAID LOBBYING FOR ANY PERSON OR ENTITY.

- 4. Article XII, section 3, Constitution of Arizona, is proposed to be amended as follows if approved by the voters and on proclamation of the Governor:
  - 3. <u>County officers; election; term of office; supervisors;</u> lobbying

Section 3. A. There are hereby created in and for each organized county of the state the following officers who shall be elected by the qualified electors thereof: a sheriff, a county attorney, a recorder, a treasurer, an assessor, a superintendent of schools and at least three supervisors, each of whom shall be elected and hold his office for a term of four (4) years beginning on the first of January next after his election, which number of supervisors is subject to increase by law. The supervisors shall be nominated and elected from districts as provided by law.

- B. The candidates for these offices elected in the general election of November 3, 1964 shall take office on the first day of January, 1965 and shall serve until the first day of January, 1969.
- C. A MEMBER OF THE COUNTY BOARD OF SUPERVISORS MAY NOT ENGAGE IN PAID LOBBYING FOR ANY PERSON OR ENTITY.
- 5. Article XIII, Constitution of Arizona, is proposed to be amended by adding section 8 as follows if approved by the voters and on proclamation of the Governor:
  - 8. <u>City or town council members: mayor: lobbying prohibited</u>

SECTION 8. A MEMBER OF A CITY OR TOWN COUNCIL OR THE MAYOR OF A CITY OR TOWN MAY NOT ENGAGE IN PAID LOBBYING FOR ANY PERSON OR ENTITY.

6. The Secretary of State shall submit this proposition to the voters at the next general election as provided by article IV, part 1, section 1, Constitution of Arizona."
