### A CONCURRENT RESOLUTION

APPLYING TO THE CONGRESS OF THE UNITED STATES TO CALL A CONVENTION FOR PROPOSING AN AMENDMENT TO THE CONSTITUTION OF THE UNITED STATES TO LIMIT THE NUMBER OF TERMS OF OFFICE OF MEMBERS OF THE UNITED STATES HOUSE OF REPRESENTATIVES AND THE UNITED STATES SENATE.

1           Whereas, Article V of the Constitution of the United States provides  
2 the states with the authority to call a convention for the purpose of  
3 proposing an amendment to the Constitution of the United States, to be  
4 ratified by the legislatures or by conventions in three-fourths of the  
5 several states on application by at least two-thirds of the states; and

6           Whereas, this power provides the States with the leverage needed to  
7 force Congress to act when it otherwise does not want to; and

8           Whereas, the citizens of the State of Arizona and twenty-two other  
9 states, having passed statutes or state constitutional amendments placing  
10 term limits on members of Congress, were overruled by the United States  
11 Supreme Court; and

12           Whereas, the Legislature of the State of Arizona hereby joins with  
13 other states in instructing Congress to draft a term limits amendment and  
14 send it to the States for ratification, failing which the States will act  
15 on their own; and

16           Whereas, the Arizona Legislature, a body of citizen legislators,  
17 desires to restore rotation in office for members serving in the Congress  
18 of the United States.

19 Therefore

20 Be it resolved by the House of Representatives of the State of Arizona,  
21 the Senate concurring:

22           1. That pursuant to Article V of the Constitution of the United  
23 States, the Legislature of the State of Arizona formally applies to the  
24 Congress of the United States to call a convention limited to proposing an  
25 amendment to the Constitution of the United States to set a limit on the  
26 number of terms a person may be elected as a Member of the United States  
27 House of Representatives and as a Member of the United States Senate.

28           2. That this application be considered as covering the same subject  
29 matter as the applications from other states to Congress to call a  
30 convention to set a limit on the number of terms that a person may be  
31 elected to the United States House of Representatives and the United  
32 States Senate, and that this application be aggregated with the  
33 applications of other states for the purpose of attaining the two-thirds  
34 of states necessary to require Congress to call a limited convention for  
35 the purpose of setting term limits on the members of Congress, but that  
36 this application not be aggregated with any other application on any other  
37 subject.

38           3. That this resolution constitutes a continuing application in  
39 accordance with Article V of the Constitution of the United States until  
40 the legislatures of at least two-thirds of the states have made  
41 applications on the same subject.

42           4. That the Secretary of State of the State of Arizona transmit a  
43 copy of this Resolution to the President of the United States Senate, the  
44 Speaker of the United States House of Representatives and each Member of  
45 Congress from the State of Arizona, and the presiding officer of each  
46 legislative house in each state, requesting their cooperation.
