## **SB 1321**

AN ACT

AMENDING TITLE 15, CHAPTER 1, ARTICLE 1, ARIZONA REVISED STATUTES, BY  
ADDING SECTION 15-120.05; RELATING TO SCHOOL ACCESS.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 15, chapter 1, article 1, Arizona Revised  
3 Statutes, is amended by adding section 15-120.05, to read:

4 15-120.05. Patriotic youth membership organizations; school  
5 access; student recruitment; eligibility;  
6 parental notification; definitions

7 A. A SCHOOL DISTRICT OR CHARTER SCHOOL MAY NOT PREVENT  
8 REPRESENTATIVES OF AN ELIGIBLE PATRIOTIC YOUTH MEMBERSHIP ORGANIZATION  
9 FROM ENGAGING IN STUDENT RECRUITMENT PURSUANT TO THIS SECTION AND MAY NOT  
10 IMPOSE LIMITS ON REPRESENTATIVES OF THE ORGANIZATION RELATING TO THE  
11 FOLLOWING ACTIVITIES:

12 1. SPEAKING WITH STUDENTS IN A CLASSROOM SETTING DURING SCHOOL  
13 HOURS AND INSTRUCTIONAL TIME.

14 2. DISTRIBUTING INFORMATIONAL MATERIALS TO STUDENTS IN A CLASSROOM  
15 SETTING DURING SCHOOL HOURS AND INSTRUCTIONAL TIME.

16 3. PROVIDING DISPLAYS AT SCHOOLS OPERATED BY THE SCHOOL DISTRICT OR  
17 CHARTER SCHOOL THAT INCLUDE INFORMATIONAL FLYERS.

18 4. PROVIDING INFORMATION ABOUT THE ORGANIZATION THROUGH THE SCHOOL  
19 DISTRICT'S OR CHARTER SCHOOL'S EXISTING COMMUNICATION CHANNELS.

20 B. A PATRIOTIC YOUTH MEMBERSHIP ORGANIZATION IS ELIGIBLE TO ENGAGE  
21 IN STUDENT RECRUITMENT PURSUANT TO THIS SECTION IF IT MEETS ALL OF THE  
22 FOLLOWING:

23 1. SERVES INDIVIDUALS WHO ARE UNDER TWENTY-ONE YEARS OF AGE.

24 2. HAS AN EDUCATIONAL PURPOSE THAT PROMOTES PATRIOTISM AND CIVIC  
25 INVOLVEMENT.

26 3. IS LISTED IN ONE OF THE FOLLOWING CHAPTERS OF THE UNITED STATES  
27 CODE IN EFFECT ON THE EFFECTIVE DATE OF THIS SECTION, OR IS THE STATE  
28 AFFILIATE OF ONE OF THE LISTED GROUPS OR ORGANIZATIONS:

29 (a) 36 UNITED STATES CODE, SUBTITLE II, PART B, CHAPTER 301.

30 (b) 36 UNITED STATES CODE, SUBTITLE II, PART B, CHAPTER 309.

38 C. IF AN ELIGIBLE PATRIOTIC YOUTH MEMBERSHIP ORGANIZATION REQUESTS  
39 TO ENGAGE IN ANY OF THE ACTIVITIES LISTED IN SUBSECTION A OF THIS SECTION,  
40 THE SCHOOL DISTRICT OR CHARTER SCHOOL MUST DO BOTH OF THE FOLLOWING AFTER  
41 THE ELIGIBLE PATRIOTIC YOUTH MEMBERSHIP ORGANIZATION REQUESTS TO ENGAGE IN  
42 THE ACTIVITY OR ACTIVITIES AT ONE OR MORE SCHOOLS OPERATED BY THE SCHOOL  
43 DISTRICT OR CHARTER SCHOOL:

1           1. SCHEDULE A DATE AND TIME DURING WHICH REPRESENTATIVES OF THE  
2 ORGANIZATION MAY ENGAGE IN THE ACTIVITIES LISTED IN SUBSECTION A OF THIS  
3 SECTION.  
4           2. IF THE ORGANIZATION REQUESTS TO SPEAK WITH STUDENTS, NOTIFY THE  
5 PARENTS AND GUARDIANS OF ALL STUDENTS ABOUT THE SCHEDULED SPEAKING  
6 ENGAGEMENT AND PROVIDE TO PARENTS AND GUARDIANS THE OPPORTUNITY TO OPT  
7 THEIR STUDENT OUT OF THE SPEAKING ENGAGEMENT.  
8           D. A SCHOOL DISTRICT OR CHARTER SCHOOL MAY NOT DISCRIMINATE AGAINST  
9 AN ELIGIBLE PATRIOTIC YOUTH MEMBERSHIP ORGANIZATION DESCRIBED IN  
10 SUBSECTION B OF THIS SECTION IN THE USE OF SCHOOL FACILITIES FOR STUDENT  
11 RECRUITMENT OUTSIDE OF THE NORMAL SCHOOL DAY.  
12           E. EXCEPT TO THE EXTENT REQUIRED BY FEDERAL LAW, THIS SECTION DOES  
13 NOT REQUIRE A SCHOOL DISTRICT OR CHARTER SCHOOL TO ALLOW AN ORGANIZATION  
14 THAT IS NOT ELIGIBLE PURSUANT TO SUBSECTION B OF THIS SECTION TO ENGAGE IN  
15 STUDENT RECRUITMENT PURSUANT TO SUBSECTION A OF THIS SECTION.  
16           F. FOR THE PURPOSES OF THIS SECTION:  
17           1. "PATRIOTISM" MEANS SUPPORT FOR THE UNITED STATES CONSTITUTION  
18 AND AMERICAN GOVERNMENT.  
19           2. "STUDENT RECRUITMENT" MEANS ACTIVITIES THAT DO ANY OF THE  
20 FOLLOWING:  
21           (a) ENCOURAGE STUDENT PARTICIPATION IN THE ORGANIZATION AND ITS  
22 ACTIVITIES.  
23           (b) INFORM STUDENTS ABOUT HOW THE ORGANIZATION MAY FURTHER A  
24 STUDENT'S EDUCATIONAL INTERESTS AND CIVIC INVOLVEMENT.  
25           (c) INFORM STUDENTS ABOUT HOW THE ORGANIZATION MAY BETTER A  
26 STUDENT'S SCHOOL, COMMUNITY AND SELF.
