1 Strike everything after the enacting clause and insert:

2 "Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes,  
3 is amended by adding section 9-500.52, to read:

4 9-500.52. Construction: summertime hours: prohibition on  
5 restriction

6 A. A MUNICIPALITY MAY NOT ENACT ANY ORDINANCE, RULE OR REGULATION  
7 THAT RESTRICTS OR PROHIBITS GENERAL CONSTRUCTION ACTIVITIES BETWEEN MAY 1  
8 AND SEPTEMBER 31 OF EACH YEAR BETWEEN THE HOURS OF 5:00 A.M. AND 7:00 P.M.  
9 EACH BUSINESS DAY IF THE CONSTRUCTION WORK IS BEING PERFORMED PURSUANT TO A  
10 VALIDLY ISSUED BUILDING PERMIT ISSUED BY THE MUNICIPALITY.

11 B. THE MUNICIPALITY SHALL ALLOW CONCRETE TO BE POURED AT LEAST ONE  
12 HOUR BEFORE THE TIME THAT GENERAL CONSTRUCTION ACTIVITIES ARE REGULARLY  
13 SCHEDULED TO BEGIN.

14 Sec. 2. Title 11, chapter 2, article 4, Arizona Revised Statutes, is  
15 amended by adding section 11-269.30, to read:

16 11-269.30. Construction: summertime hours: prohibition on  
17 restriction

18 A. A COUNTY MAY NOT ENACT ANY ORDINANCE, RULE OR REGULATION THAT  
19 RESTRICTS OR PROHIBITS GENERAL CONSTRUCTION ACTIVITIES BETWEEN MAY 1 AND  
20 SEPTEMBER 31 OF EACH YEAR BETWEEN THE HOURS OF 5:00 A.M. AND 7:00 P.M. EACH  
21 BUSINESS DAY IF THE CONSTRUCTION WORK IS BEING PERFORMED PURSUANT TO A  
22 VALIDLY ISSUED BUILDING PERMIT ISSUED BY THE COUNTY.
